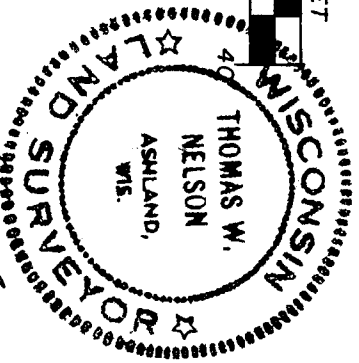

SURVEYOR'S CERTIFICATE

I, Thomas W. Nelson, Registered Land Surveyor, hereby certify:

That on the order of Robert W. Norlin, Attorney, I have surveyed, divided, and mapped the following described property located in Gov't. Lot 1, Section 7, T. 48 N., R. 4 W., in the Town of Barksdale, Bayfield County, Wisconsin.

To locate the Point of Beginning, commence at the N 1/4 corner of said Section 7, and run N 89°-32' W, along the North line of said Section 7, to its intersection with the centerline of the Chicago, St. Paul, Minneapolis, and Omaha Railway, 198.20 feet. Thence, S 01°-00'-30" W, along said centerline, 1221.86 feet. Thence, S 89°-32' E, parallel to the North line of Section 7, 50.00 feet, to a railroad spike on the Easterly R/W line of said Railway, which is the Point of Beginning.

Thence from said Point of Beginning by metes and bounds:

Continuing S 89°-32' E, 125.57 feet to a 1-1/4 inch iron pipe which is N 89°-32' W, 38 feet, ±, from the water's edge of Lake Superior.

Thence along a meander line near said water's edge:

N 06°-48'-13" E, 50.31 feet to a 1-1/4 inch iron pipe.

Thence, N 13°-51' E, 154.15 feet to a 1-1/4 inch iron pipe which is N 89°-32' W, 20 feet, +, from the water's edge of Lake Superior.

Thence, leaving said meander line, N 89°-32' W, parallel to the North line of said Section 7, 164.91 feet to a railroad spike on the Easterly R/W line of said Railway.


Thence, S 01°-00'-30" W, 199.97 feet to the Point of Beginning.

Parcel includes that land lying between the meander line and the water's edge of Lake Superior, and the extensions of the North and South lot lines to said water's edge.

Parcel includes 0.66 acres.

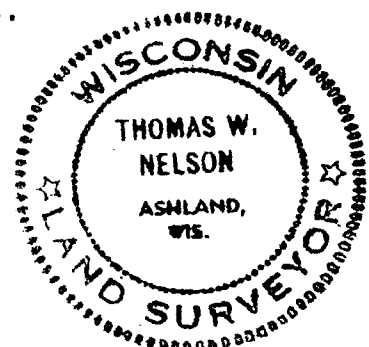
That this Certified Survey Map is a correct representation of all the exterior boundaries of the land surveyed and the subdivision thereof.
