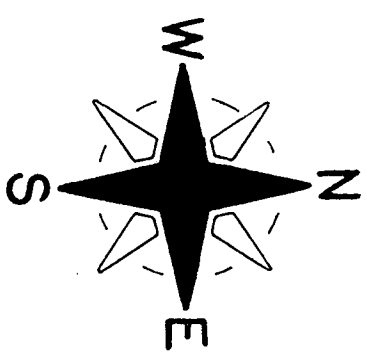
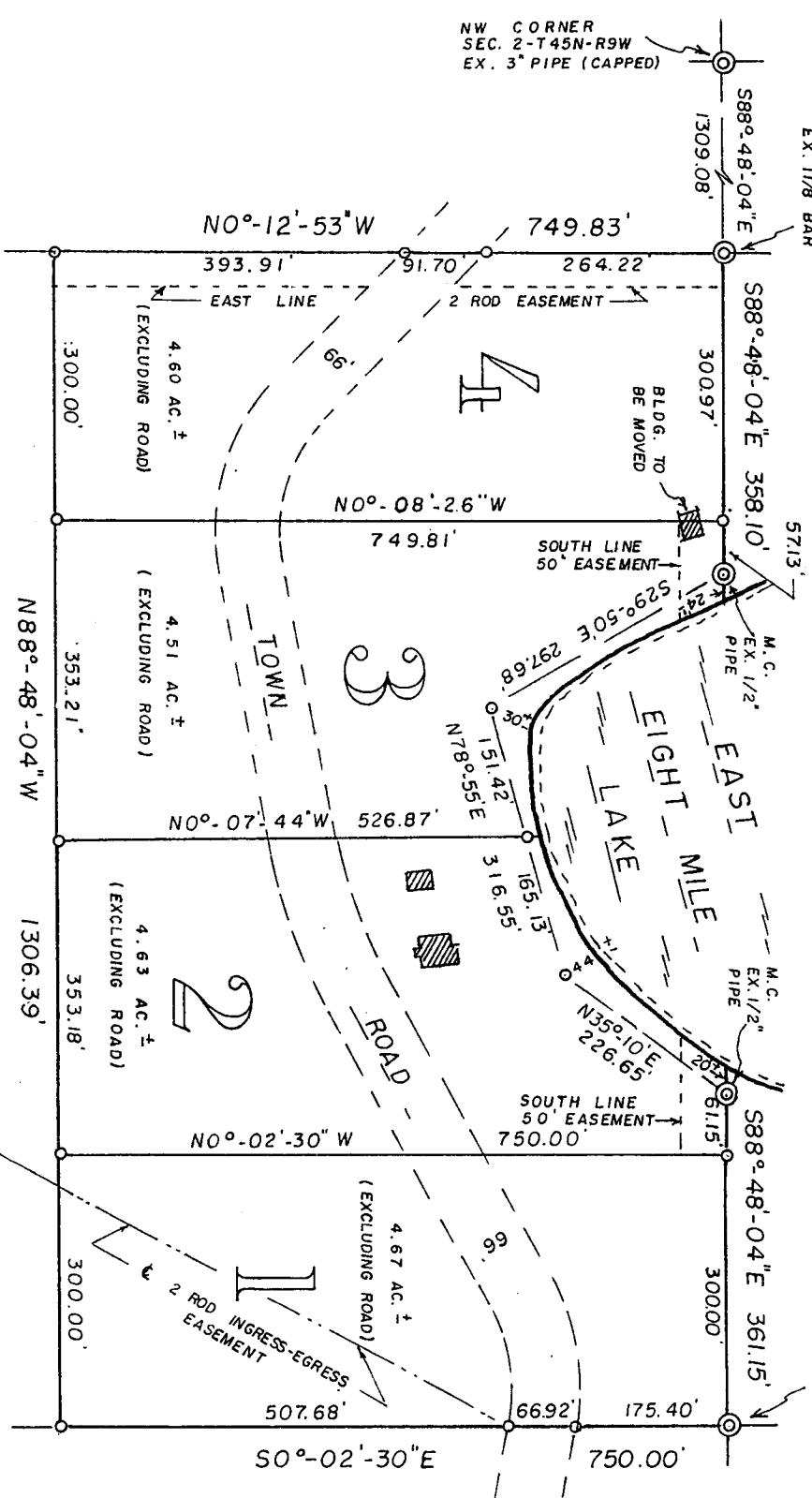

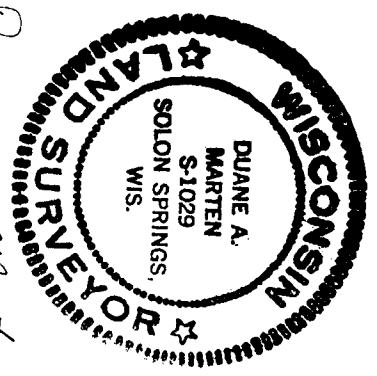

SURVEYOR'S CERTIFICATE

I, Duane A. Marten, Registered Land Surveyor, hereby certify: That I have divided and mapped that part of Frac. NE $\frac{1}{4}$ -NW $\frac{1}{4}$, Sec. 2-T45N-R9W, Town of Barnes, Bayfield County, Wisconsin, bounded and described as follows: Beginning at the N $\frac{1}{4}$ corner of said Sec. 2; thence S06'-02'-30"E along the N-S $\frac{1}{4}$ line, 750.00 feet; thence N880-48'-04"W parallel with the North line of the Sec., 1306.39 feet to the West line of the forty; thence N00'-12'-53"W along the West line of the forty, 749.83 feet to the North line of the Sec.; thence S880-48'-04"E along said North line, 358.10 feet to a point 24 feet, more or less, from the water's edge of East Eight Mile Lake; thence S290-50'E along a meanderline, 297.68 feet; thence N780-55'E along a meanderline, 316.55 feet; thence N350-10'E along a meanderline, 226.65 feet to a point 20 feet, more or less, from the water's edge of East Eight Mile Lake and the North line of the Sec.; thence S880-48'-04"E along said North line, 361.15 feet to the point of beginning. Including all lands lying between the above described meanderline and the water's edge of East Eight Mile Lake. (*)

That such plat is a correct representation of all exterior boundaries of the land surveyed and the subdivision thereof made.

(*) Subject to lands now being used for Town Road purposes and all other easements and reservations of record.

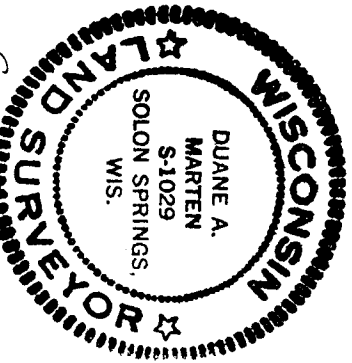
