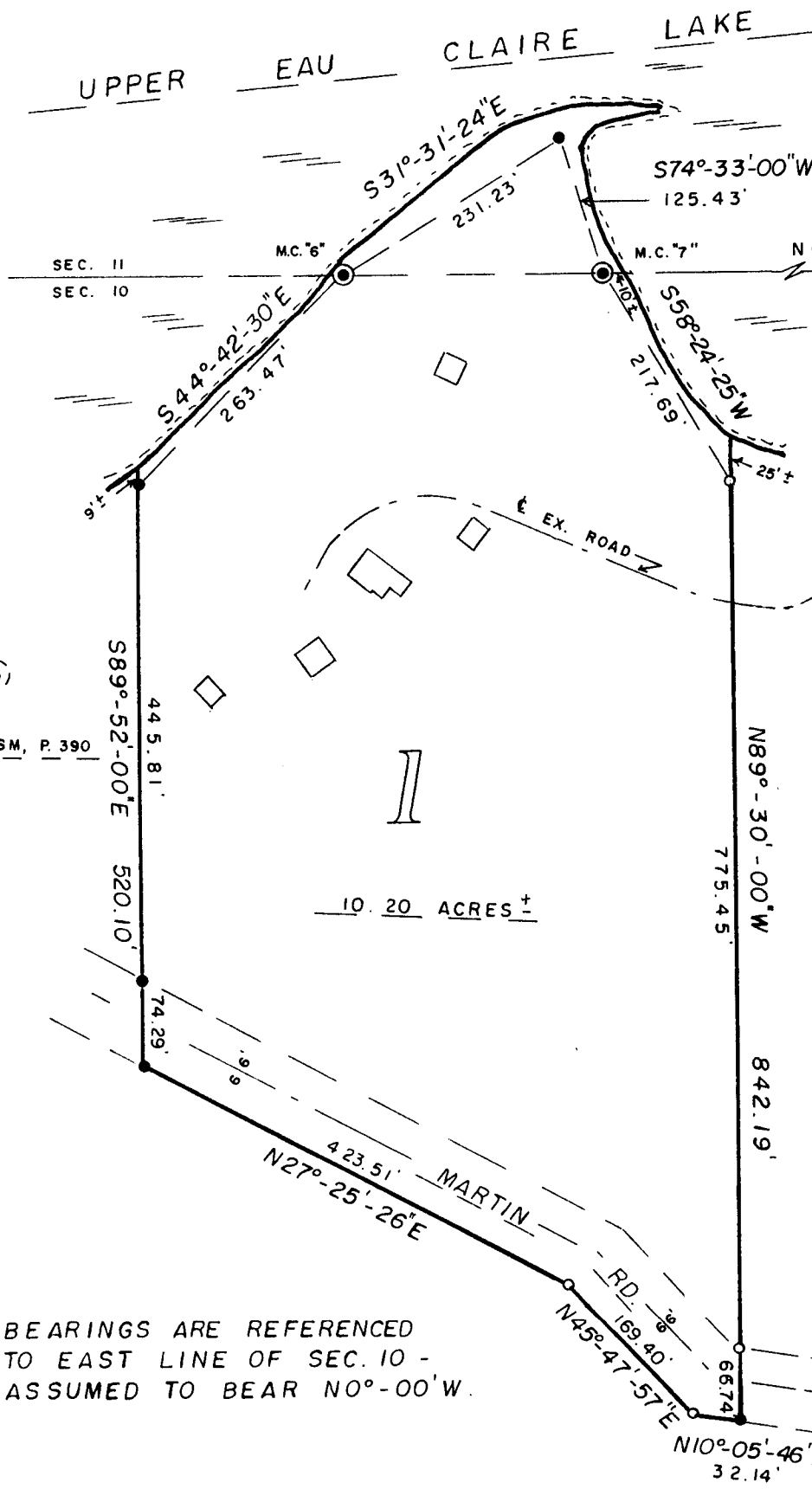
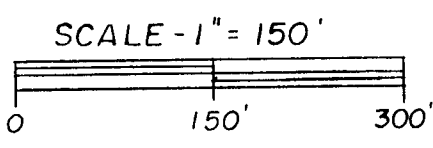
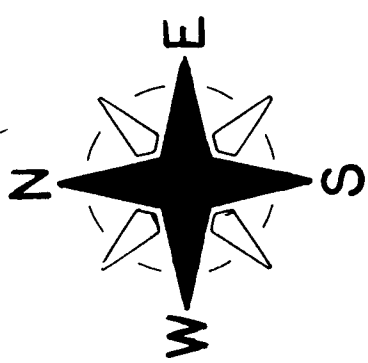


BAYFIELD CO. CERTIFIED SURVEY MAP NO. 1055

Surveyor's Certificate:

I, Duane A. Marten, Registered Land Surveyor, hereby certify:

That I have surveyed and mapped that part of Gov't. Lot 4, Sec. 10 and that part of Gov't. Lot 1, Sec. 11 all in T44N-R9W, Town of Barnes, Bayfield County, Wisconsin, bounded and described as follows:

Commencing at the SE corner of said Sec. 10; thence North 0 degrees, 00 minutes West along the East line of said Sec. 10, 1781.85 feet to M.C. "7" (said point being 10 feet, more or less, from the water's edge of Upper Eau Claire Lake) and the point of beginning; thence South 58 degrees, 24 minutes, 25 seconds West along a meanderline, 217.69 feet to a point 25 feet, more or less, from the water's edge of the Upper Eau Claire Lake; thence North 89 degrees, 30 minutes, 00 seconds West, 842.19 feet to the West line of Martin Road; thence North 10 degrees, 05 minutes, 46 seconds East along said West line 32.14 feet; thence North 45 degrees, 47 minutes, 57 seconds East along said West line, 169.40 feet; thence North 27 degrees, 25 minutes, 26 seconds East along said West line, 423.51 feet; thence South 89 degrees, 52 minutes, 00 seconds East, 520.10 feet to a point 9 feet, more or less, from the water's edge of Upper Eau Claire Lake; thence South 44 degrees, 42 minutes, 30 seconds East along a meanderline, 263.47 feet; thence South 31 degrees, 31 minutes, 24 seconds East along a meanderline, 231.23 feet; thence South 74 degrees, 33 minutes, 00 seconds West along a meanderline, 125.43 feet to a point 10 feet, more or less, from the water's edge of Upper Eau Claire Lake and the point of beginning. Including all lands lying between the above described meanderline and the water's edge of Upper Eau Claire Lake. Subject to the Westerly 66 feet thereof now being used for roadway purposes and all other easements and reservations of record.
