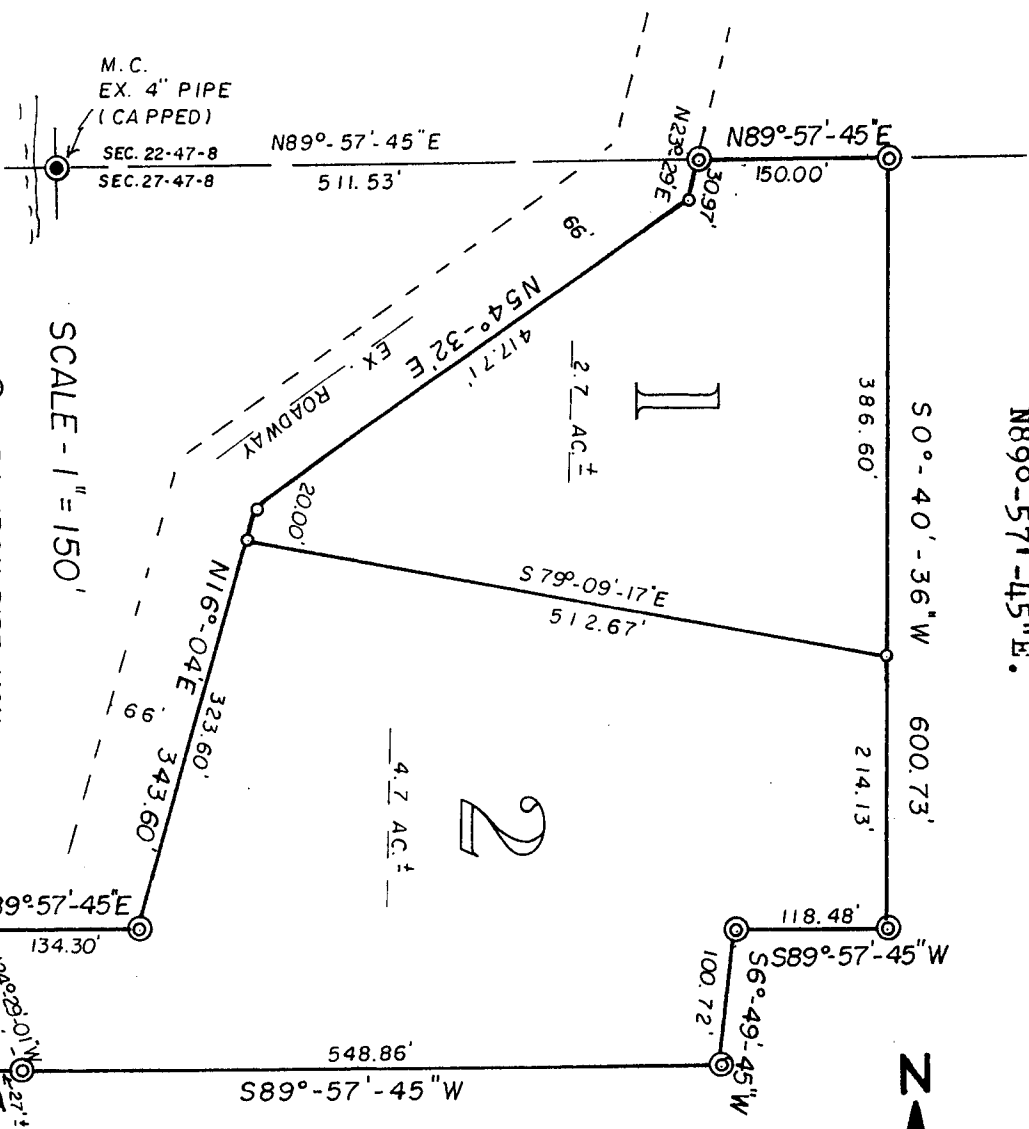
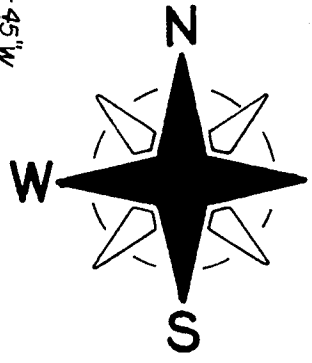

Commencing at the Meander Corner on the East shore of Lake Millicent between Sec's. 22 and 27; thence N89°-57'-45"E along the North line of said Sec. 27, thence 511.53 feet to the point of beginning; thence continuing N89°-57'-45"E, 150.00 feet; thence S00°-40'-36"W, 600.73 feet; thence S89°-57'-45"W, 118.48 feet; thence S60°-49'-45"W, 100.72 feet; thence S89°-57'-45"W, 548.86 feet to a point 27 feet, more or less, from the water's edge of Lake Millicent; thence N24°-29'-01"W along a meanderline, 109.84 feet to a point 20 feet, more or less, from the water's edge of Lake Millicent; thence N89°-57'-45"E, 134.30 feet; thence N16°-04'E, 343.60 feet; thence N54°-32'E, 417.71 feet; thence N23°-29'E, 30.97 feet to the point of beginning. 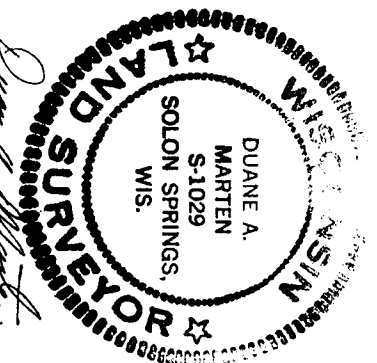
