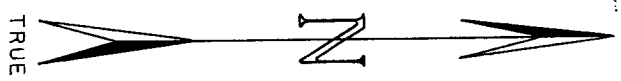

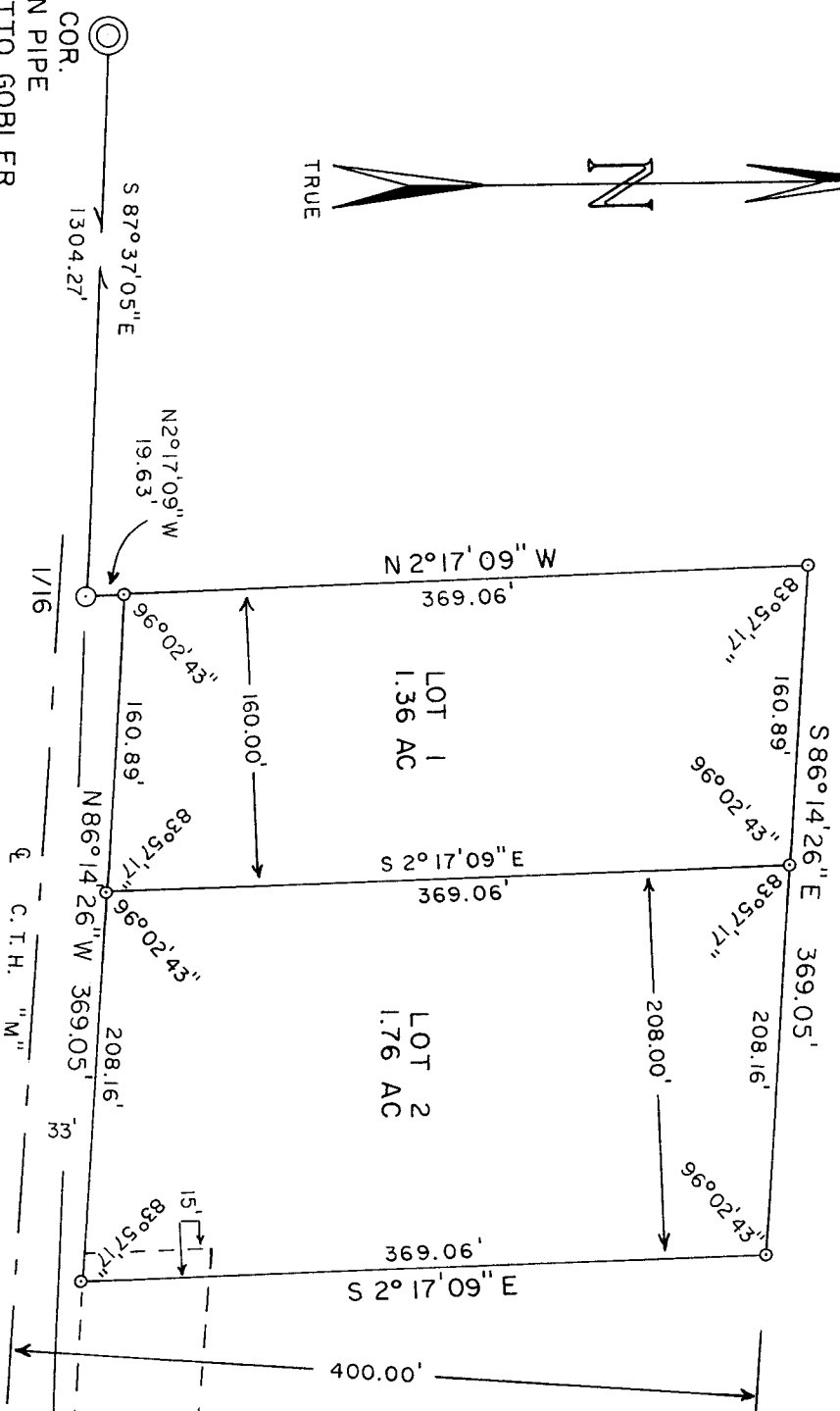

I, Ladd D. Gould, Registered Land Surveyor, do hereby certify:

That I have surveyed, divided, and mapped part of Gov't. Lot 3 of Section 16, Township 43 North, Range 7 West, Town of Cable, Bayfield County, Wisconsin, more particularly described as follows:

Commencing at a 1-3/4 inch iron pipe marking the West 1/4 Corner of Section 16, T 43 N, R 7 W; thence along the east/west 1/4 line S 87° 37' 05" E, 1304.27 feet to a 1-3/4 inch iron pipe marking the 1/16 corner; thence N 2° 17' 09" W, 19.63 feet to a 1 inch iron pipe marking the north Right-of-Way line of County Trunk Highway "M" and the Point of Beginning; thence continuing N 2° 17' 09" W, 369.06 feet to a 1 inch iron pipe; thence S 86° 14' 26" E, 369.05 feet to a 1 inch iron pipe; thence S 2° 17' 09" E, 369.06 feet to a 1 inch iron pipe marking the north Right-of-Way of County Trunk Highway "M"; thence along the north edge of the Highway Right-of-Way N 86° 14' 26" W, 369.05 feet to the Point of Beginning.

That I have made such survey and map by the direction of the owner of said lands; That such map is a correct representation of all exterior boundaries of the land surveyed and the subdivision thereof made; That I have fully complied with the provisions of Chapter 236 of the Wisconsin Statutes and the subdivision regulations of Bayfield County in the surveying and mapping of same.
