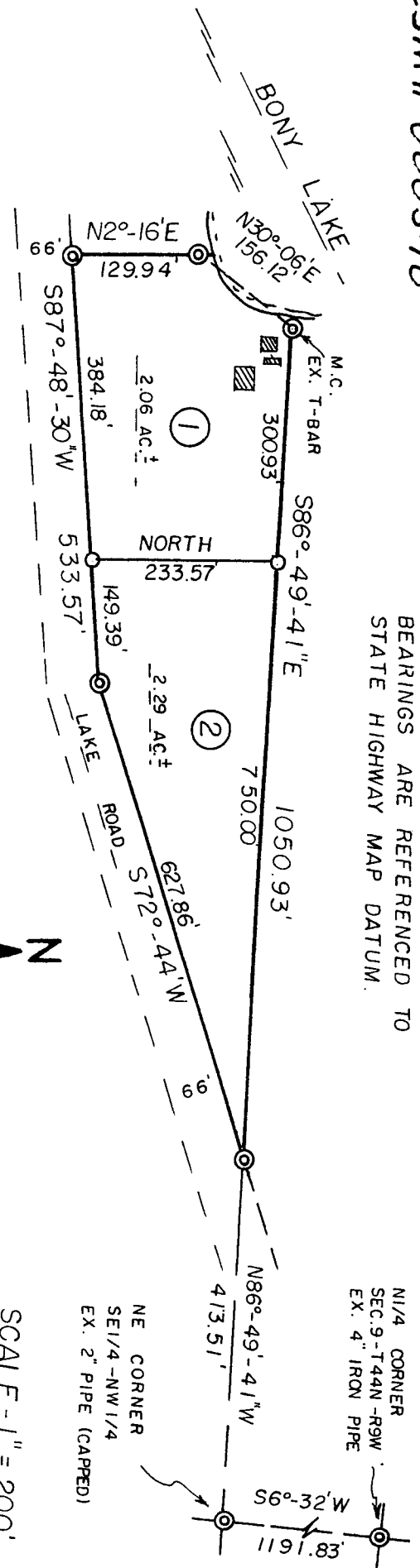

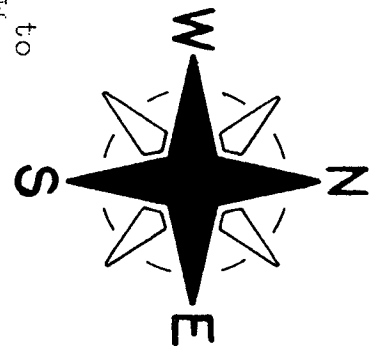

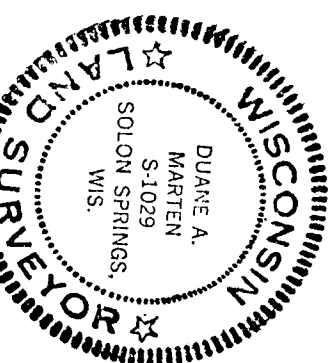

Including all lands lying between the above described meanderline and the respective lines extended to the waters edge of Bony Lake.
