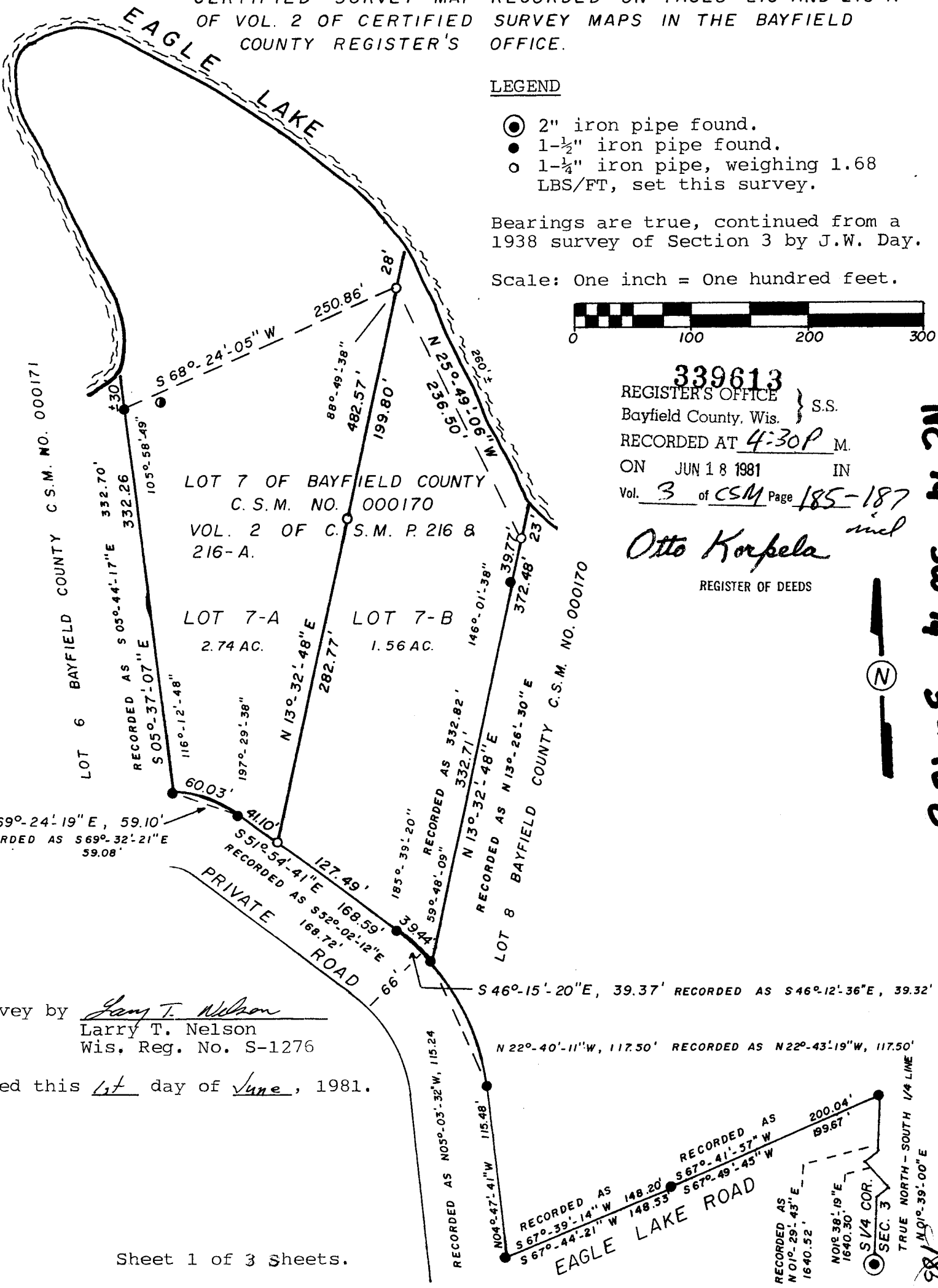

I, Larry T. Nelson, registered land surveyor, hereby certify:

That on the order of Smith Insurance and Real Estate, Inc., Donald S. Smith, President, I have surveyed, divided and mapped the following described property located in the NE 1/4 of the SW 1/4 of Section 3, T. 46 N., R. 8 W., in the Town of Delta, Bayfield Co. Wisconsin. Lot 7 of Bayfield County Certified Survey Map No. 000170, recorded on Pages 216 and 216-A of Vol. 2 of Bayfield County Certified Survey Maps.

Beginning at the SE corner of said Bayfield County Certified Survey Map No. 000170, run N 13°-32'-48" E, 372.48 feet to a 1-1/4" iron pipe near the water's edge of Eagle Lake; Thence along a meander line near said water's edge, N 25°-49'-06" W, 236.50 feet to a 1-1/4" iron pipe; Thence S 68°-24'-05" W, 250.86 feet to a 1-1/2" iron pipe; Thence leaving said meander line, S 05°-37'-07" E, 332.26 feet to a 1-1/2" iron pipe on the northerly right-of-way line of a 66' wide Private Road; Thence along said northerly right-of-way line, along the arc of a curve to the right, having a central angle of 35°-00'-52", a radius of 98.23', a chord bearing S 69°-24'-19" E and measuring 59.10 feet, 60.03 feet to a 1-1/2" iron pipe; Thence S 51°-54'-41" E, 168.59 feet to a 1-1/2" iron pipe; Thence along the arc of a curve to the right, having a central angle of 11°-40'-10", a radius of 193.64', a chord bearing S 46°-15'-20" E and measuring 39.37 feet, 39.44 feet to the Point of Beginning. Parcel includes that land lying between the meander line and the water's edge of Eagle Lake and the extensions of the East and West lot lines to said water's edge. Parcel contains 4.3 Ac., more or less.
