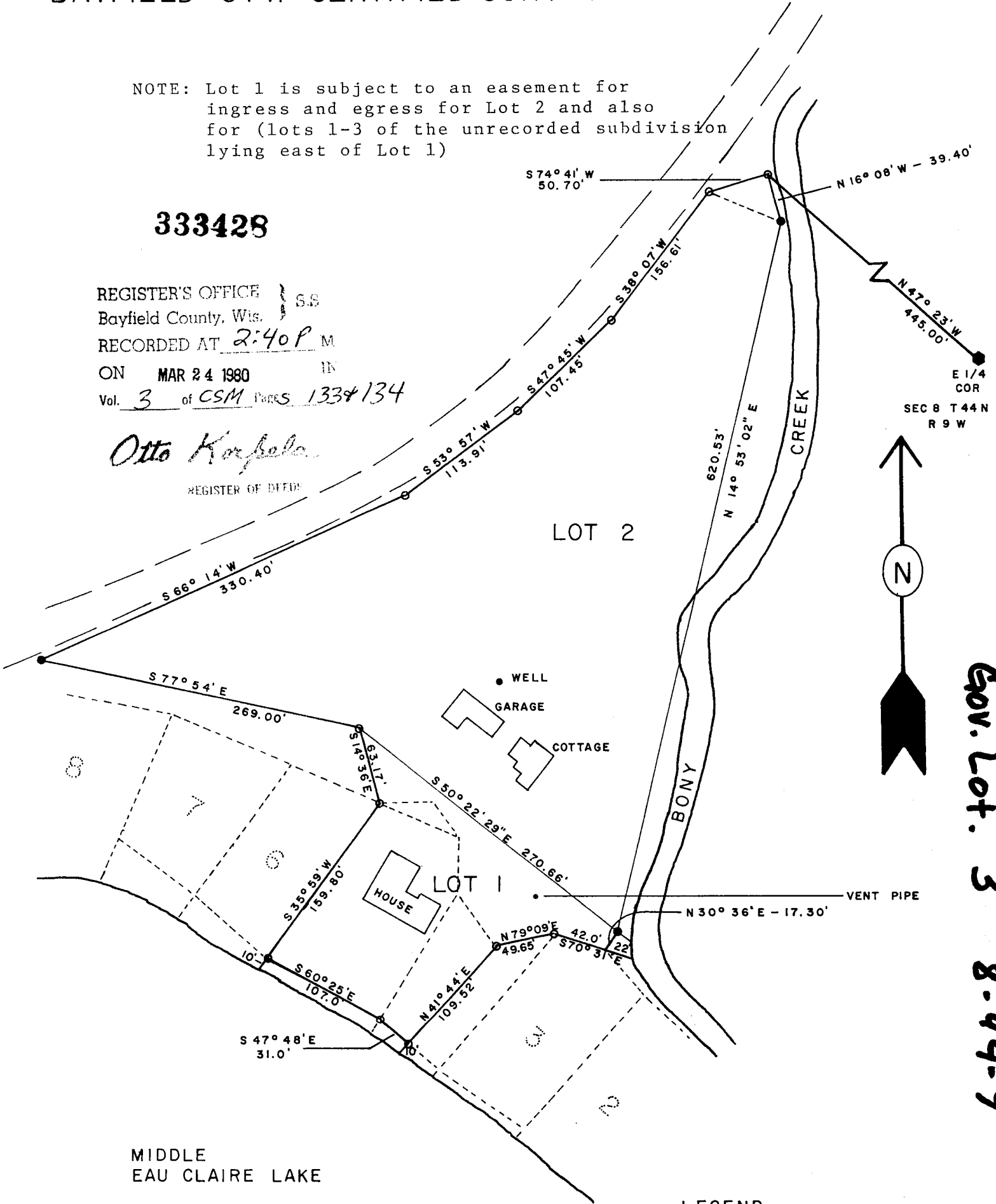

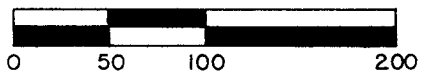
Gov. Lot. 3 8-44-9

Commencing at the East 1/4 Corner of said Section 8; thence N47°23'W 445.00 feet to the point of beginning; thence N16° 08'W 39.40 feet; thence S74° 41'W 50.70 feet; thence S38° 07'W 156.61 feet; thence S47° 45'W 107.45 feet; thence S53° 57'W 113.91 feet; thence S66° 14'W 330.40 feet; thence S77° 54'E 269.00 feet; thence S14° 36'E 63.17 feet; thence S 35° 59'W 159.80 feet to the start of a meander line; thence S60° 25'E 107.00 feet along said meander line; thence S47° 48'E 31.00 feet along said meander line; thence N41° 44'E 109.52 feet; thence N79° 09'E 49.65 feet; thence S70° 31'E 42.00 feet to the start of a meander line for Bony Creek; thence N30° 36'E 17.30 feet and along said meander line; thence continuing along said meander line N14° 53' 02"E 620.53 feet to the point of beginning.
