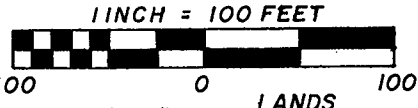

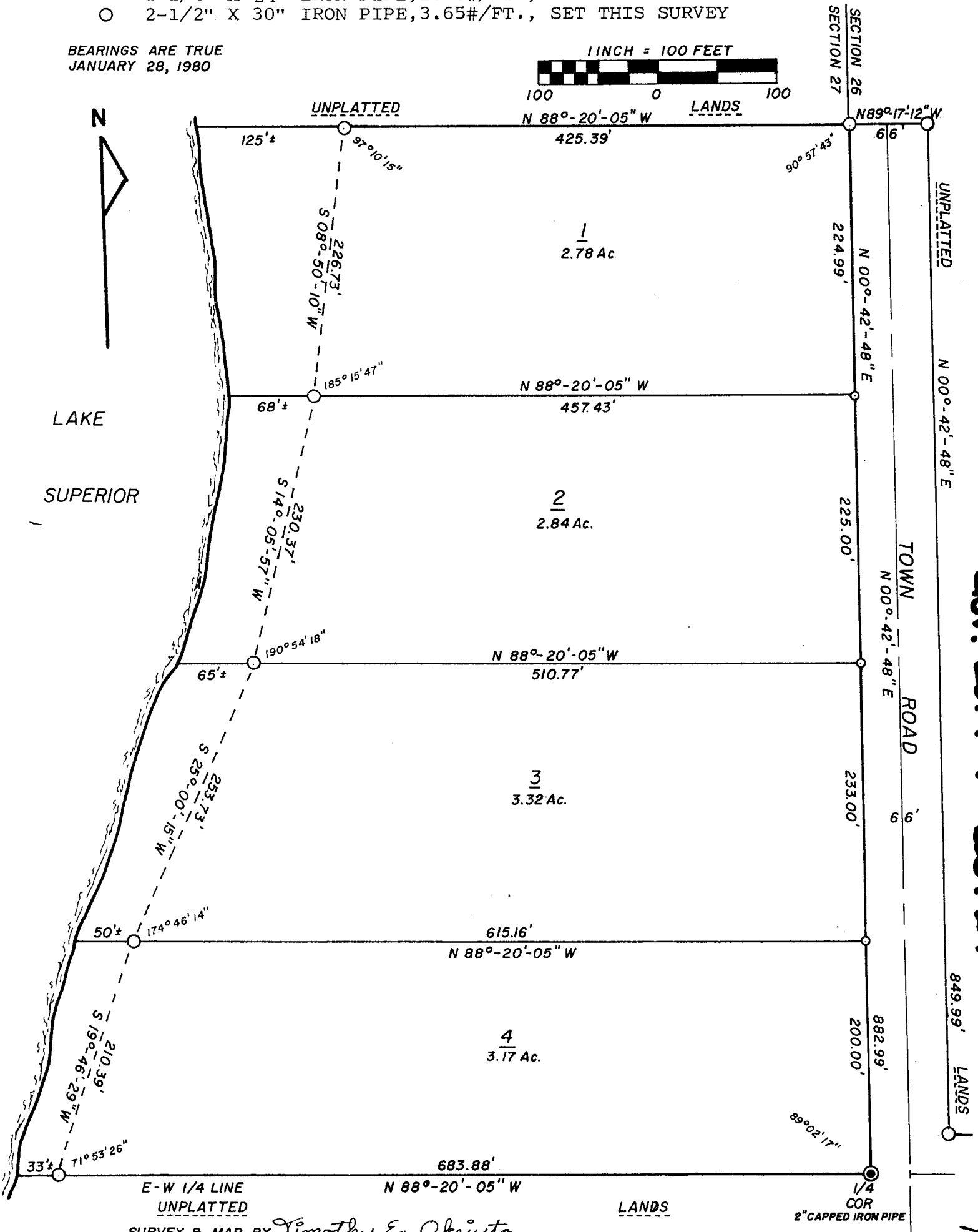

SURVEYOR'S CERTIFICATE

I, Timothy E. Oksiuta, Registered Land Surveyor, hereby certify:

That on the order of L. Fred Robbins, I have surveyed, divided, and mapped the following described property located in the S 1/3 of Gov't Lot 1, Section 27, T. 51 N., R. 6 W., in the Town of Bell, Bayfield County, Wisconsin;

Beginning at the E 1/4 corner of said Section 27, run N 00°-42'-48" E, 882.99 feet along the East line of said Section, to a 2-1/2" iron pipe. Thence N 88°-20'-05" W, 425.39 feet, parallel with the E-W 1/4 line of said Section 27, to a 2-1/2" iron pipe. Thence along a meander line near the shore of Lake Superior S 08°-50'-10" W, 226.73 feet to a 2-1/2" iron pipe. Thence S 14°-05'-57" W, 230.37 feet to a 2-1/2" iron pipe. Thence S 25°-00'-15" W, 253.73 feet to a 2-1/2" iron pipe. Thence S 19°-46'-29" W, 210.39 feet to a 2-1/2" iron pipe on the E-W 1/4 line of said Section 27. Thence leaving said meander line, S 88°-20'-05" E, 683.88 feet along said E-W 1/4 line to the Point of Beginning.

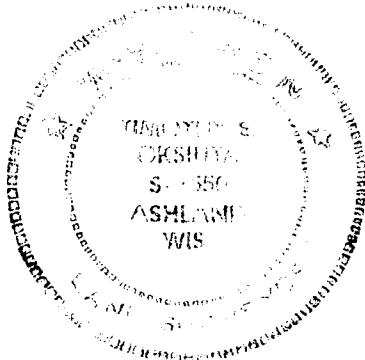
