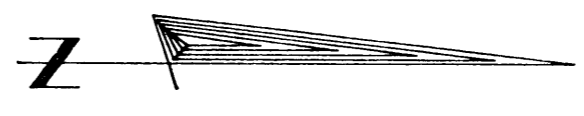


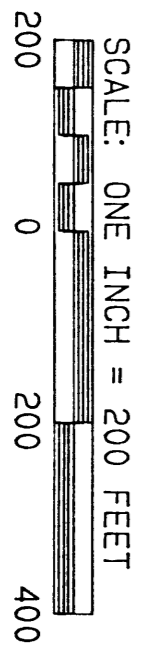
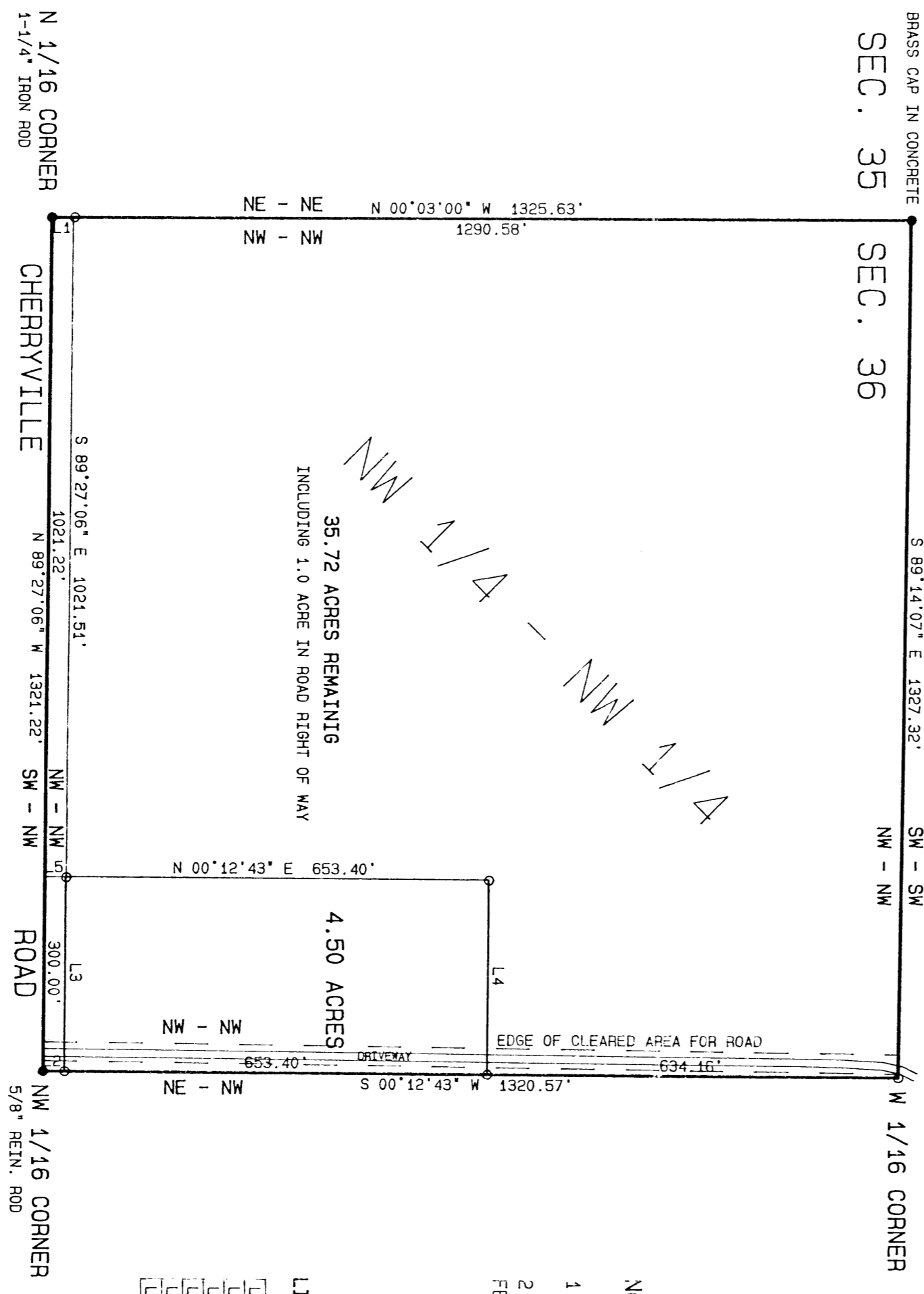
MAP OF SURVEY

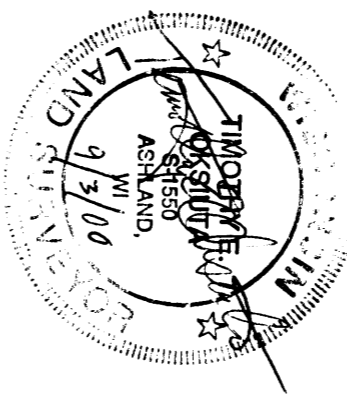

DESCRIPTION OF 4.50 ACRE PARCEL
A PARCEL OF LAND LOCATED IN THE NW 1/4 OF THE NW 1/4 OF SECTION 36, T. 48 N., R. 6 W., IN THE TOWN OF BARKSDALE, BAYFIELD COUNTY, WISCONSIN, DESCRIBED AS FOLLOWS:
TO LOCATE THE POINT OF BEGINNING, COMMENCE AT THE NW CORNER OF SAID SECTION 36 AND RUN S 00°03'00" E, 1325.63 FEET, ALONG THE WEST LINE OF SAID SECTION 36, TO THE SW CORNER OF SAID NW 1/4 OF THE NW 1/4. THENCE LEAVING SAID WEST LINE, AND ALONG THE SOUTH LINE OF SAID NW 1/4 OF THE NW 1/4, S 89°27'06" E, 1021.22 FEET. THENCE LEAVING SAID SOUTH LINE, N 00°12'43" E, 33.00 FEET TO 1-1/2" IRON PIPE ON THE NORTH RIGHT OF MAY LINE OF CHERRYVILLE ROAD, WHICH IS THE POINT OF BEGINNING.
THENCE FROM SAID POINT OF BEGINNING BY METES AND BOUNDS:
CONTINUE N 00°12'43" E, 653.40 FEET, PARALLEL WITH THE EAST LINE OF SAID NW 1/4 OF THE NW 1/4, TO A 1-1/2" IRON PIPE;
THENCE S 89°27'06" E, 300.00 FEET, PARALLEL WITH THE SOUTH LINE OF SAID NW 1/4 OF THE NW 1/4, TO A 1-1/2" IRON PIPE ON THE EAST LINE OF SAID NW 1/4 OF THE NW 1/4;
THENCE ALONG SAID EAST LINE, S 00°12'43" W, 653.40 FEET TO A 1-1/2" IRON PIPE ON THE NORTH RIGHT OF MAY LINE OF CHERRYVILLE ROAD.
THENCE LEAVING SAID EAST LINE AND ALONG SAID NORTH RIGHT OF MAY LINE, N 89°27'06" W, 300.00 FEET TO THE POINT OF BEGINNING.
SAID PARCEL IS SUBJECT TO EASEMENTS AND RESERVATIONS OF RECORD.
