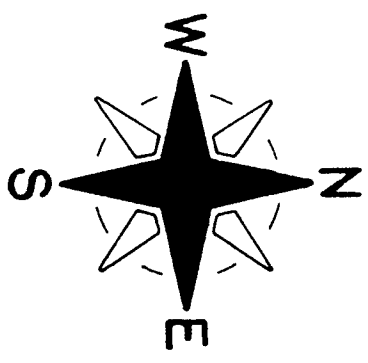
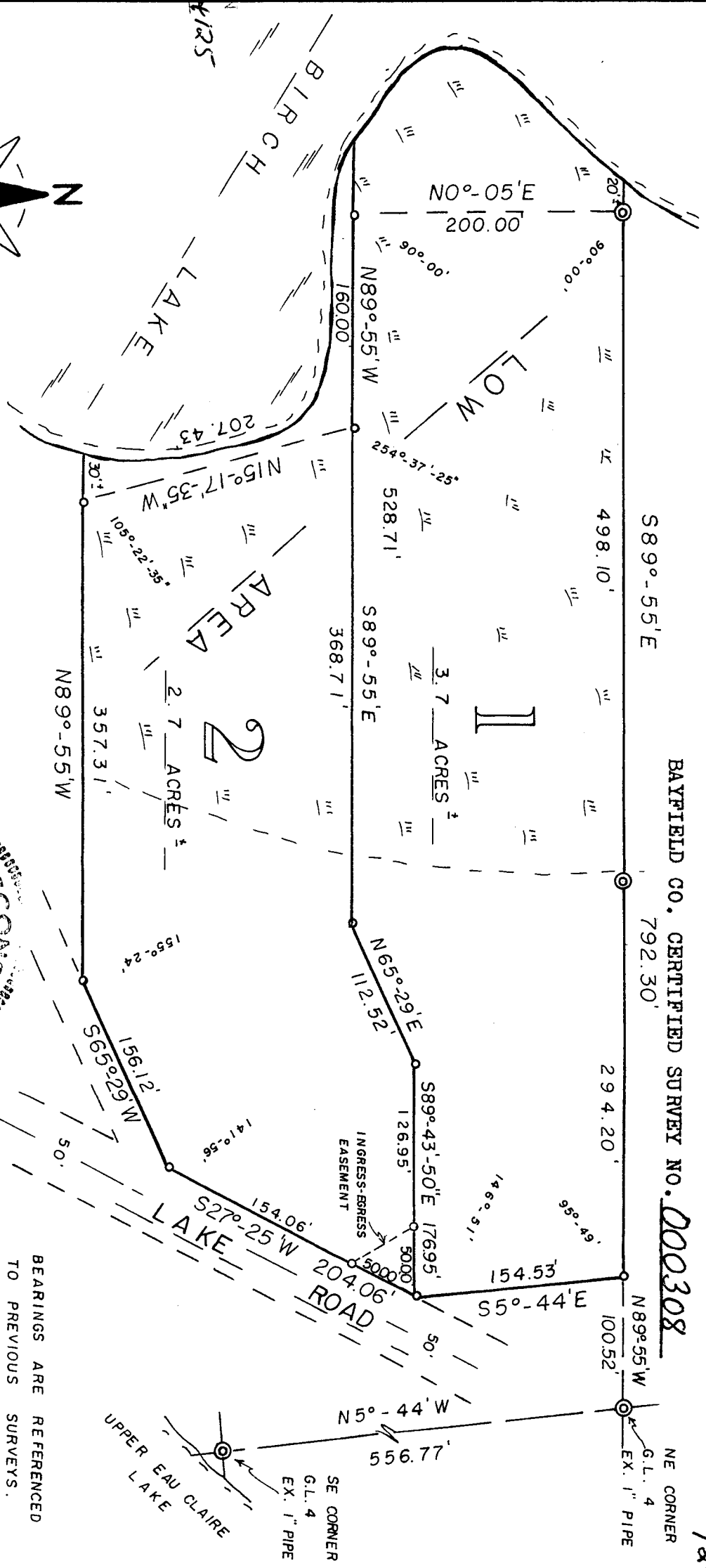

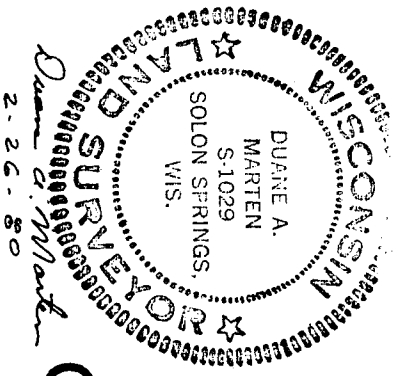

SURVEYOR'S CERTIFICATE

I, Duane A. Marten, Registered Land Surveyor, hereby certify:

That I have surveyed, divided and mapped that part of Gov't. Lot 4, Sec. 3-T44N-R9W, Town of Barnes, Bayfield County, Wisconsin, bounded and described as follows:

Commencing at the SE corner of said Gov't. Lot 4: thence N50-44'W along the East line of said Gov't. Lot 4, 556.77 feet; thence N890-55'W, 100.52 feet to the point of beginning; thence S50-44'E, 154.53 feet to the Northwestery line of Lake Road; thence S270-25'W along said Northwestery line, 204.06 feet; thence S650-29'W, 156.12 feet; thence N890-55'W, 357.31 feet to a point 30 feet, more or less, from the water's edge of Birch Lake; thence N150-17'-35"W along a meanderline, 207.43 feet; thence N890-55'W, along a meanderline, 160.00 feet; thence N00-05'E along a meanderline, 200.00 feet to a point 20 feet, more or less, from the water's edge of Birch Lake; thence S890-55'E, 792.30 feet to the point of beginning.
