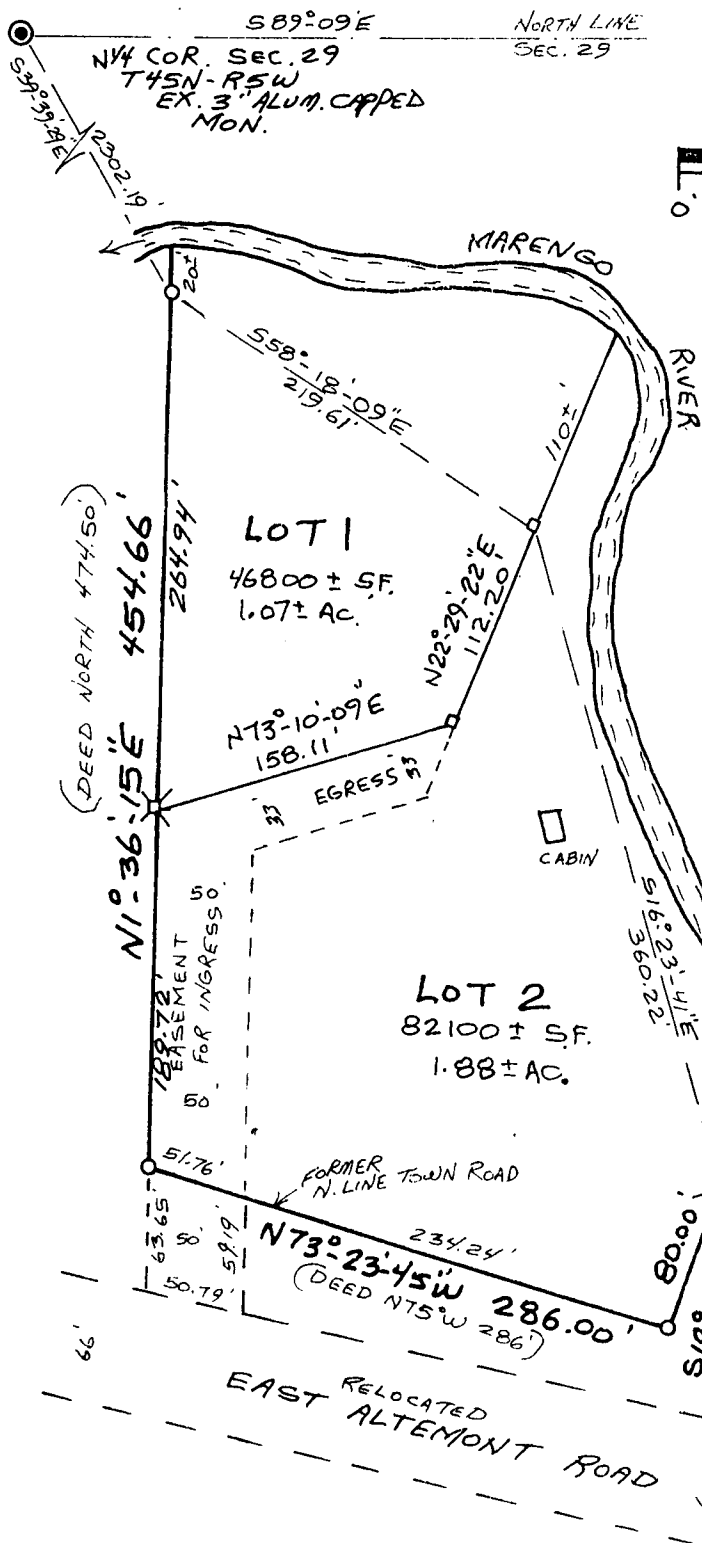

NORTH LINE SECTION 29 ASSUMED TO BEAR S89°09'E



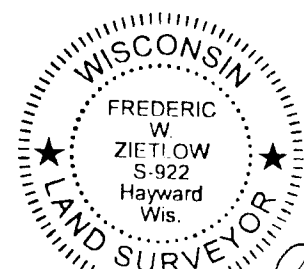
