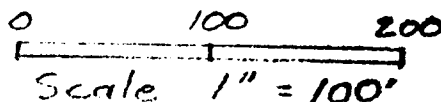

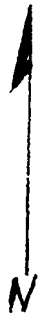

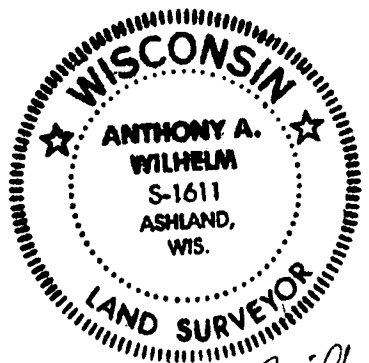
Gov. Lot 4, SEC 18

Previously Established as N 17° 42' 59" E

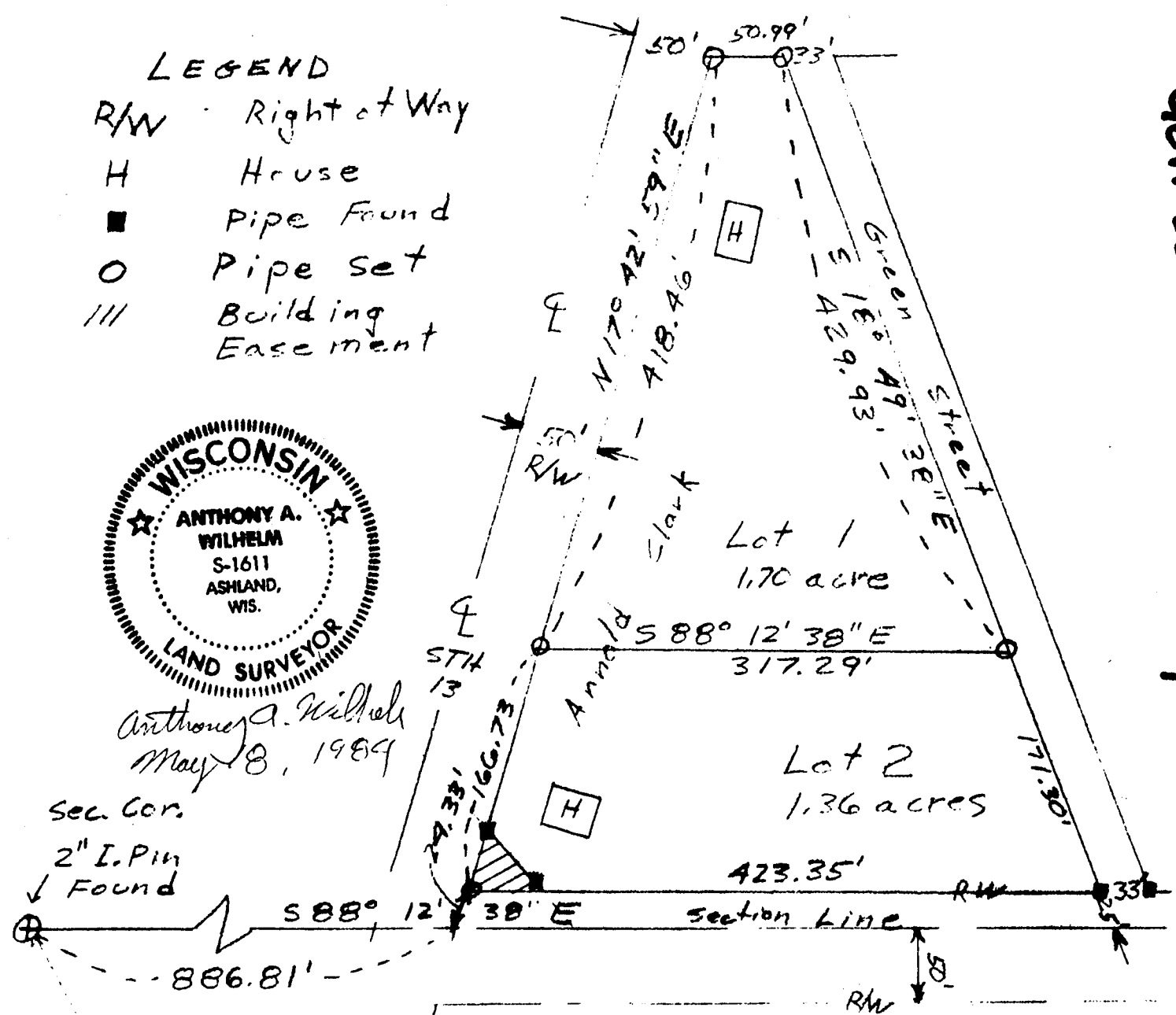

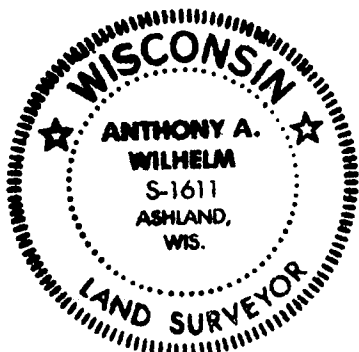
