

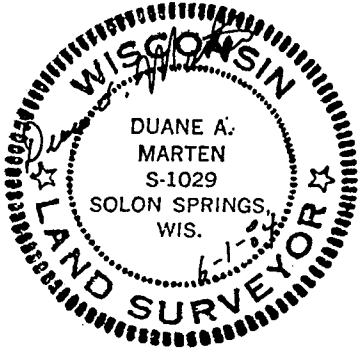
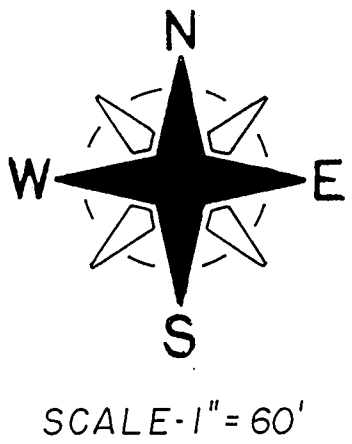
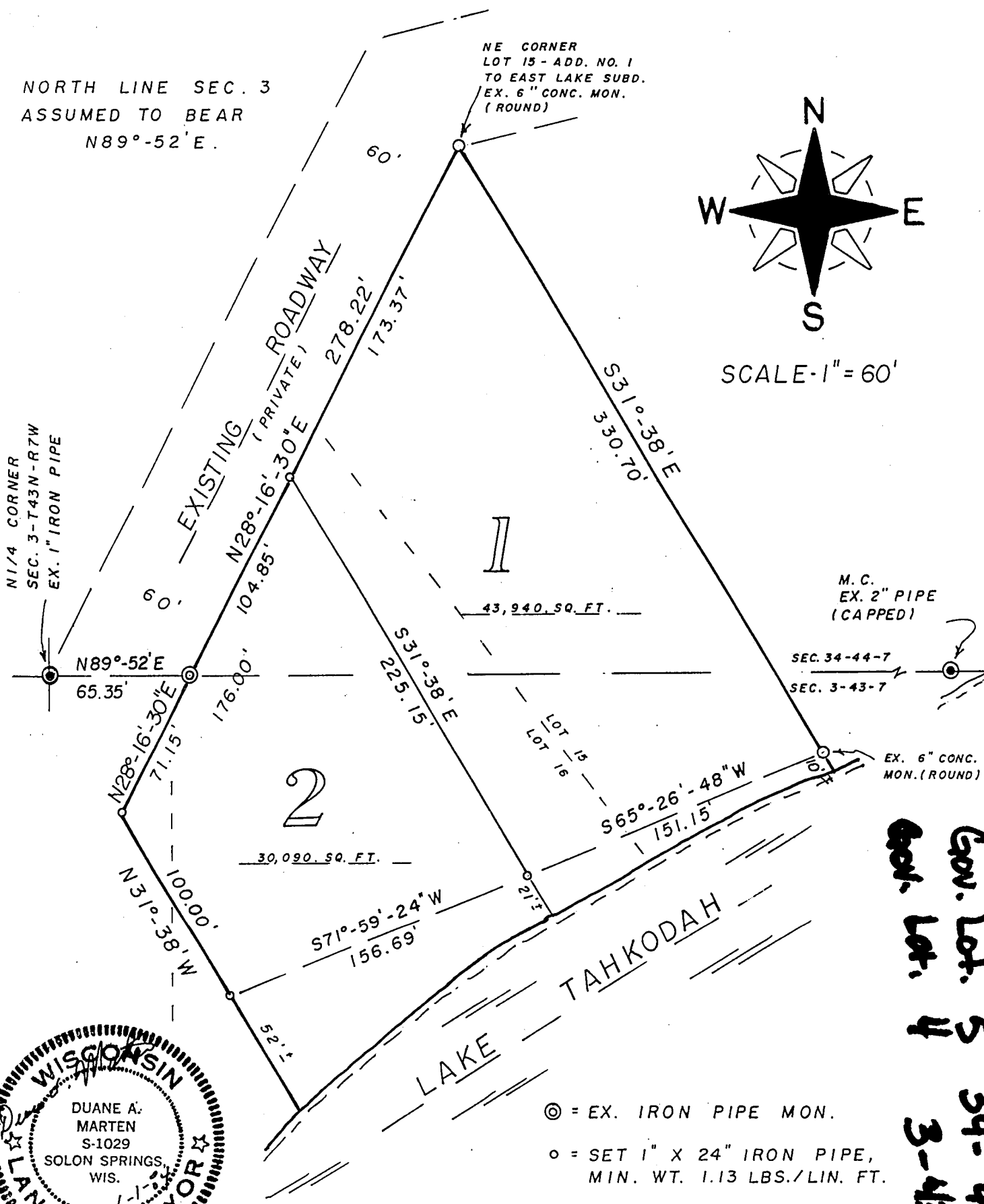

SURVEYOR'S CERTIFICATE

I, Duane A. Marten, Registered Land Surveyor, hereby certify:

That I have surveyed, divided and mapped that part of Gov't. Lot 5, Sec. 34-T44N-R7W, Town of Drummond and that part of Gov't. Lot 4, Sec. 3-T43N-R7W, Town of Cable, Bayfield County, Wisconsin, bounded and described as follows:

Commencing at the N $\frac{1}{4}$ corner of said Sec. 3; thence N89°-52'E along the North line of the Sec., 65.35 feet to the Southeasterly line of an existing roadway and the point of beginning; thence N28°-16'-30"E along said Southeasterly line, 278.22 feet; thence S31°-38'E, 330.70 feet to a point 10 feet, more or less, from the water's edge of Lake Tahkodah; thence S65°-26'-48"W along a meanderline, 151.15 feet; thence S71°-59'-24"W along a meanderline, 156.69 feet to a point 52 feet, more or less, from the water's edge of Lake Tahkodah; thence N31°-38'W, 100.00 feet to the Southeasterly line of an existing roadway; thence N28°-16'-30"E along said Southeasterly line, 71.15 feet to the point of beginning. Including all lands lying between the above described meanderline and the water's edge of Lake Tahkodah. Subject to all easements and reservations of record.

That such plat is a correct representation of all exterior boundaries of the land surveyed and the subdivision thereof made.
