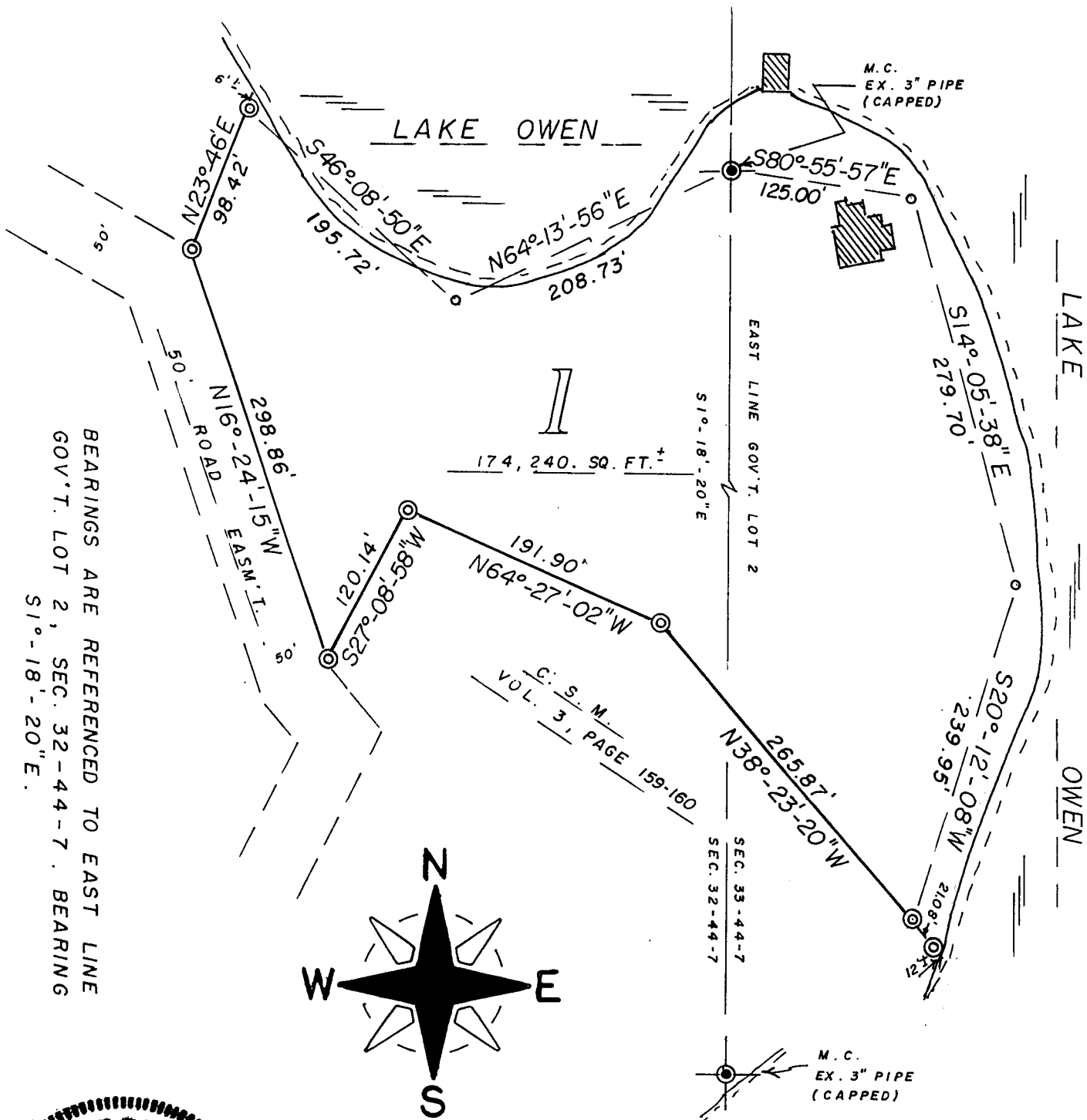

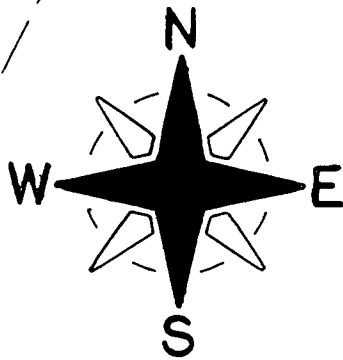

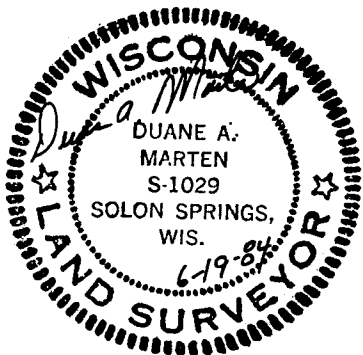
Gov. Lot. 2 Sec 32 Gov. Lot. 1 33-44-7

SURVEYOR'S CERTIFICATE

I, Duane A. Marten, Registered Land Surveyor, hereby certify:

That I have surveyed, divided and mapped that part of Gov't. Lot 2 Sec. 32 and in Gov't. Lot 1, Sec. 33-T44N-R7W, Town of Drummond, Bayfield County, Wisconsin, bounded and described as follows:

Beginning at the meander corner on the Southeasterly shore of Lake Owen, between Sections 32 and 33; thence S80°-55'-57"E along a meanderline, 125.00 feet; thence S14°-05'-38"E along a meanderline, 279.70 feet; thence S20°-12'-08"W along a meanderline, 239.95 feet to a point 33 feet, more or less, from the water's edge of Lake Owen; thence N38°-23'-20"W, 265.87 feet; thence N64°-27'-02"W, 191.90 feet; thence S27°-08'-58"W, 120.14 feet to the Easterly line of a 50 foot roadway; thence N16°-24'-15"W along said Easterly line, 298.86 feet; thence N23°-46'E, 98.42 feet to a point 6 feet, more or less, from the water's edge of Lake Owen; thence S46°-08'-50"E along a meanderline, 195.72 feet; thence N64°-13'-56"E along a meanderline, 208.73 feet to the point of beginning. Including all lands lying between the above described meanderline and the water's edge of Lake Owen. Subject to all easements and reservations of record.

That such plat is a correct representation of all exterior boundaries of the land surveyed and the subdivision thereof made.

That I have made such survey, land division and plat by the order and under the direction of Mr. Don Stahl.

That I have fully complied with Chapter 236.34 of the Wisconsin Statutes and the subdivision regulations of Bayfield County to the best of my knowledge and belief.
