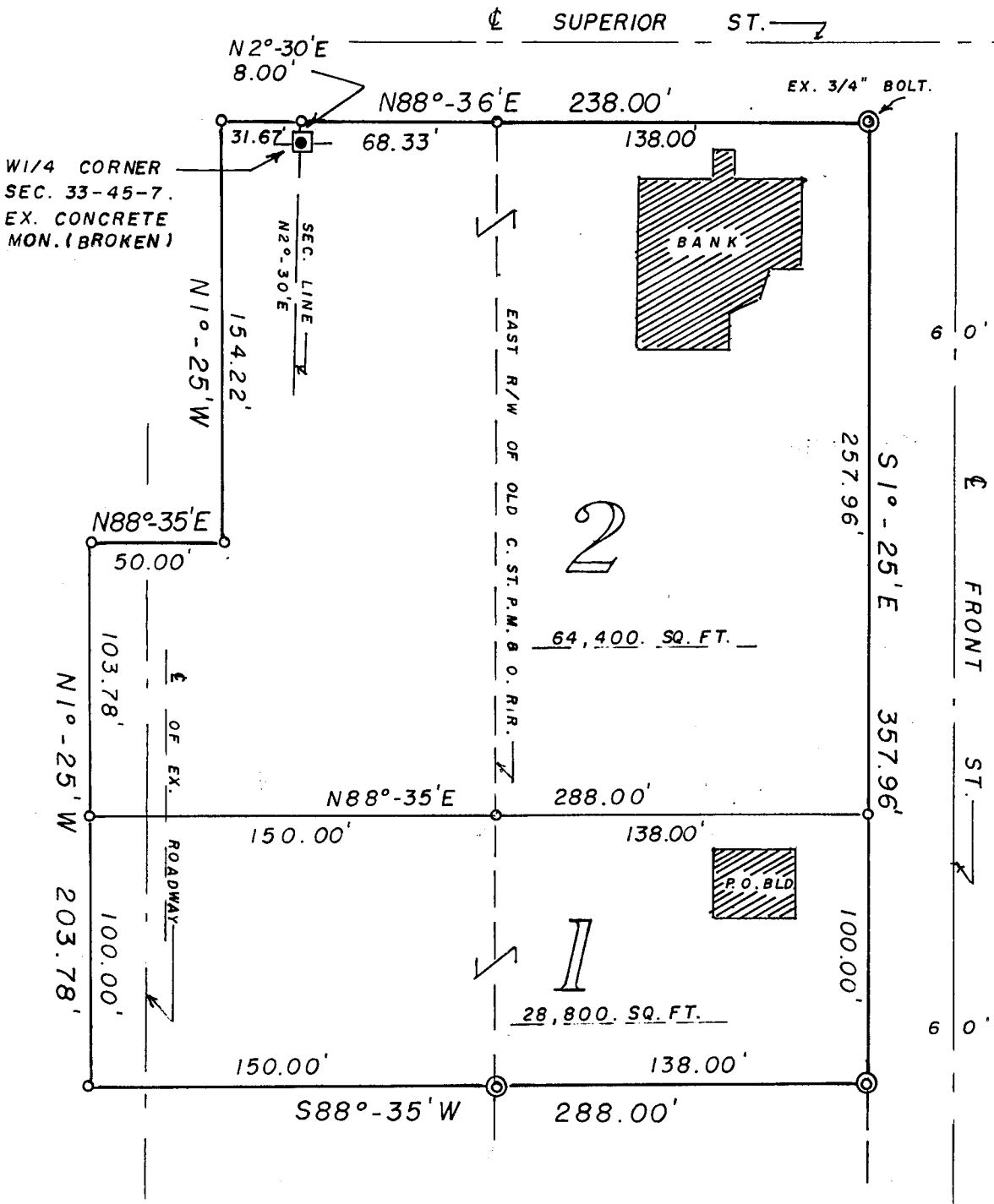

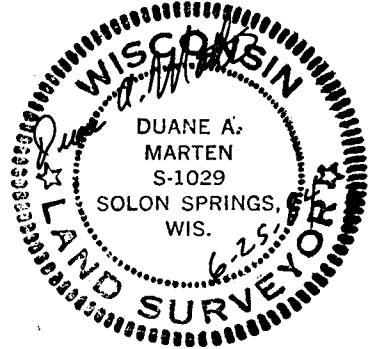

SURVEYOR'S CERTIFICATE

I, Duane A. Marten, Registered Land Surveyor, hereby certify:

That I have surveyed, divided and mapped that part of the SW $\frac{1}{4}$ -NW $\frac{1}{4}$ & NW $\frac{1}{4}$ -SW $\frac{1}{4}$, Sec. 33 and the NE $\frac{1}{4}$ -SE $\frac{1}{4}$ & part of Gov't. Lot 2, Sec. 32 all in T45N-R7W, Town of Drummond, Bayfield County, Wisconsin, bounded and described as follows:

Commencing at the W $\frac{1}{4}$ corner of said Sec. 33; thence N2 $^{\circ}$ -30'E, 8.00 feet to the South line of Superior Street and the point of beginning; thence N88 $^{\circ}$ -36'E along said South line, 206.33 feet to the West line of Front Street; thence S1 $^{\circ}$ -25'E along said West line, 357.96 feet; thence S88 $^{\circ}$ -35'W, 288.00 feet; thence N1 $^{\circ}$ -25'W, 203.78 feet; thence N88 $^{\circ}$ -35'E, 50.00 feet; thence N1 $^{\circ}$ -25'W, 154.22 feet to the South line of Superior Street; thence N88 $^{\circ}$ -36'E along said South line, 31.67 feet to the point of beginning. Subject to an existing roadway as now being traveled. Also subject to all other easements and reservations of record.

That such plat is a correct representation of all exterior boundaries of the land surveyed and the subdivision thereof made.
