

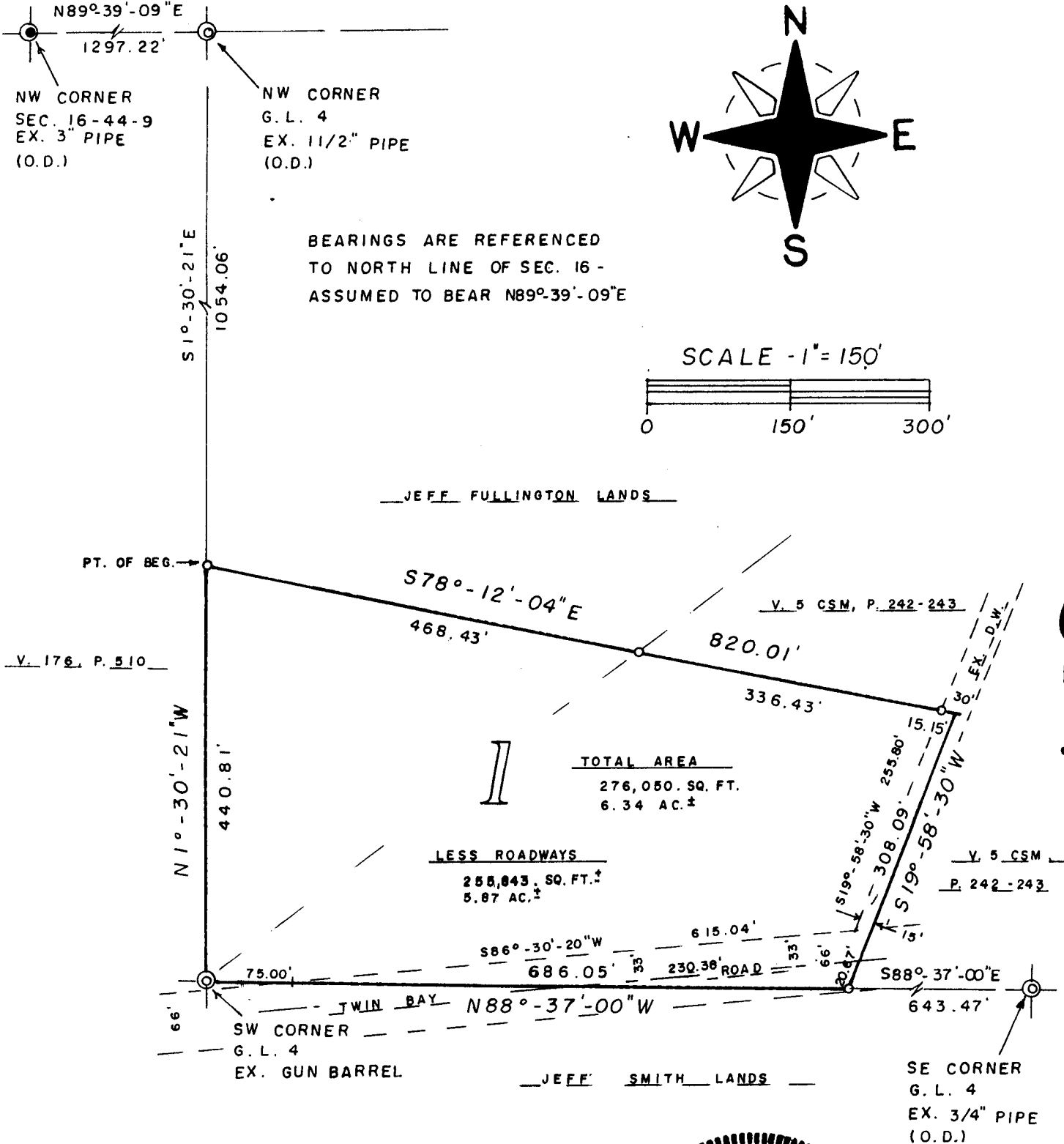

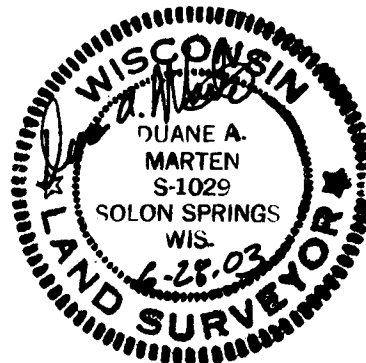

Surveyor's Certificate:

I, Duane A. Marten, Registered Land Surveyor, hereby certify:

That I have surveyed and mapped that part of Gov't. Lot 4, Sec. 16-T44N-R9W, Town of Barnes, Bayfield County, Wisconsin, bounded and described as follows:

Commencing at the NW corner of said Sec. 16; thence North 89 degrees, 39 minutes, 09 seconds East along the North line of the Sec., 1297.22 feet to the NW corner of Gov't. Lot 4; thence South 1 degree, 30 minutes, 21 seconds East along the West line of Gov't. Lot 4, 1054.06 feet to the point of beginning; thence South 78 degrees, 12 minutes, 04 seconds East, 820.01 feet to the centerline of an existing Driveway; thence South 19 degrees, 58 minutes, 30 seconds West along said centerline, 308.09 feet to the South line of Gov't. Lot 4; thence North 88 degrees, 37 minutes, 00 seconds West along said South line, 686.05 feet to the SW corner of said Lot 4; thence North 1 degree, 30 minutes, 21 seconds West along the West line of Gov't. Lot 4, 440.81 feet to the point of beginning. Subject therefrom those lands now being used for Town Road and Driveway purposes and all other easements and reservations of record.
