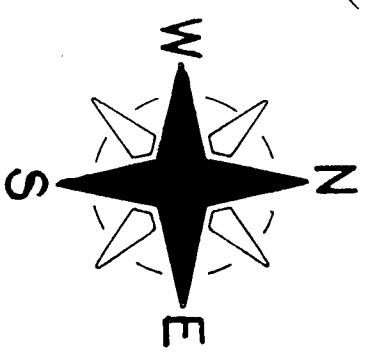
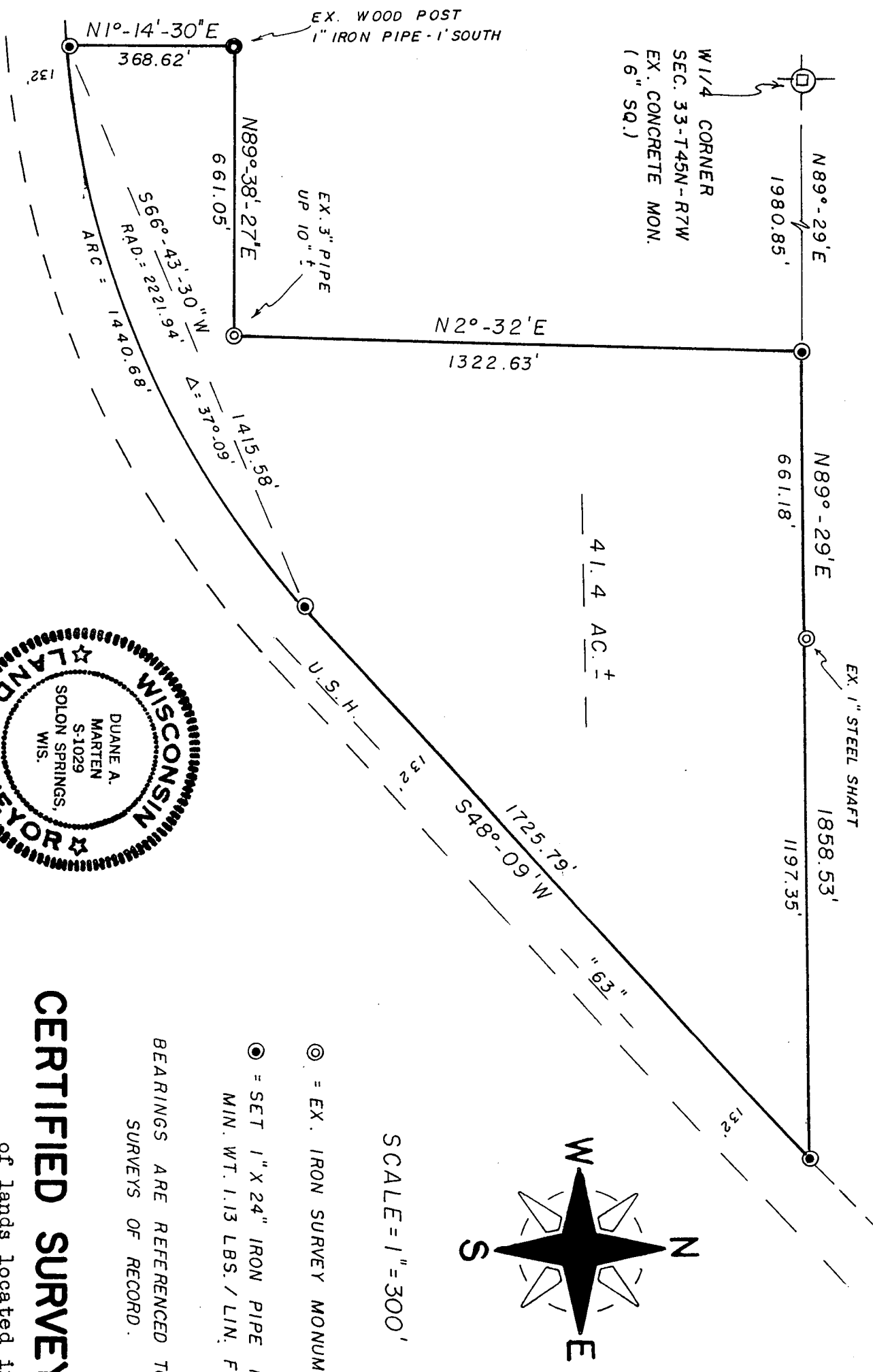

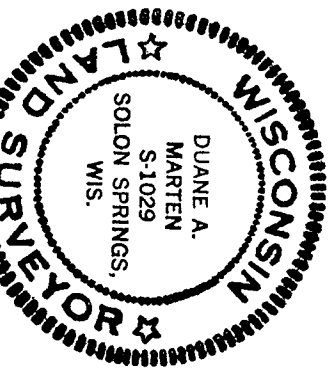

SURVEYOR'S CERTIFICATE

I, Duane A. Marten, Registered Land Surveyor, hereby certify: That I have surveyed, divided and mapped that part of the NE $\frac{1}{4}$ -SW $\frac{1}{4}$, SE $\frac{1}{4}$ -SW $\frac{1}{4}$ and NW $\frac{1}{4}$ -SE $\frac{1}{4}$, Sec. 33-T45N-R7W, Town of Drummond, Bayfield County, Wisconsin, bounded and described as follows:

Commencing at the W $\frac{1}{4}$ corner of said Sec. 33; thence N89 $^{\circ}$ -29'E, 1980.85 feet to the point of beginning; thence continuing N89 $^{\circ}$ -29'E, 1858.53 feet to the Northwesterly line of U.S.H. "63"; thence S48 $^{\circ}$ -09'W along said line 1725.79 feet; thence continuing along said line on a curve concave to the Northwest and having a radius of 2221.94 feet (the chord of which bears S66 $^{\circ}$ -43'-30"W, 1415.58 feet) a distance of 1440.68 feet; thence N1 $^{\circ}$ -14'-30"E, 368.62 feet; thence N89 $^{\circ}$ -38'-27"E, 661.05 feet; thence N2 $^{\circ}$ -32'E, 1322.63 feet to the point of beginning. Subject to all easements and reservations of record.

That such plat is a correct representation of all exterior boundaries of the land surveyed.

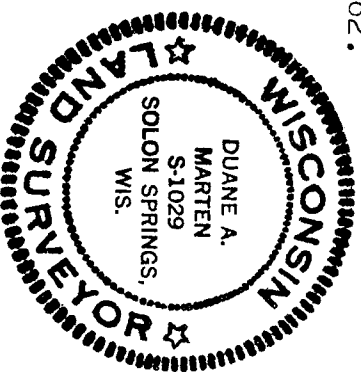
