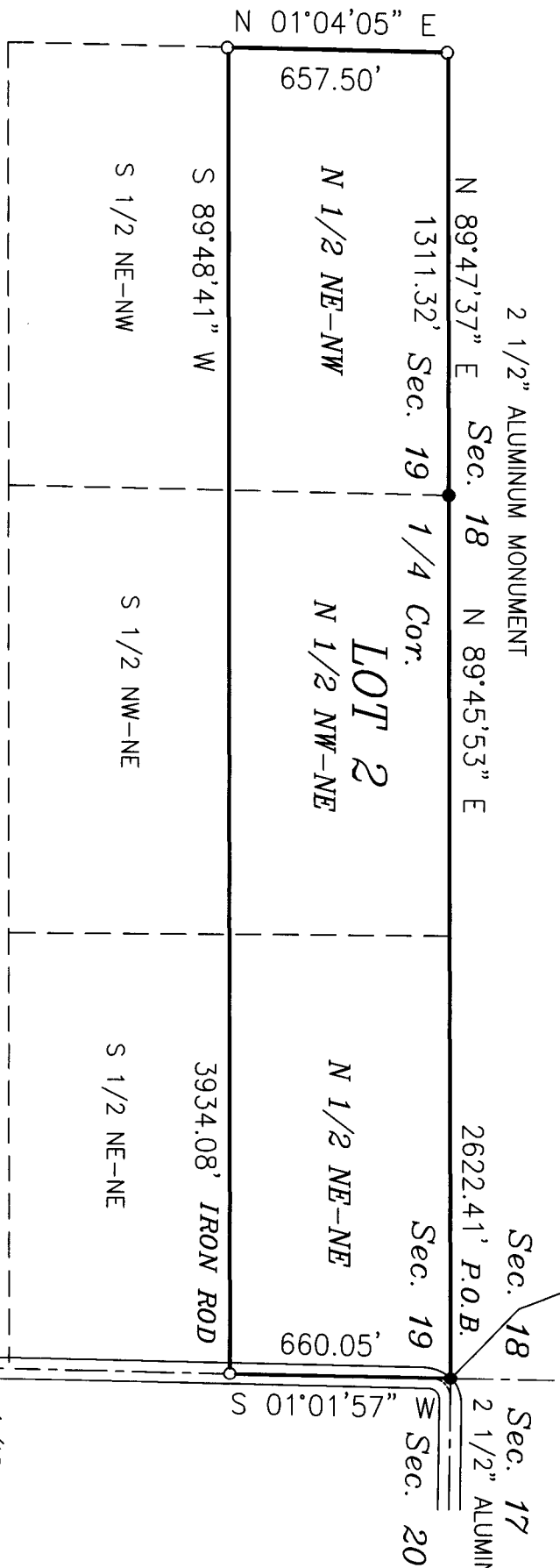

# MAP OF SURVEY - LOT 2

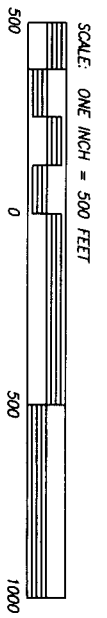

BEGINNING AT THE NORTHEAST CORNER OF SAID SECTION 19, RUN S 01°01'57" W, 660.05 FEET ALONG THE EAST LINE OF SAID SECTION; THENCE LEAVING SAID EAST LINE OF SECTION 19, S 89°48'41" W, 3934.08 FEET; THENCE N 01°04'05" E, 657.50 FEET TO THE NORTH LINE OF SAID SECTION 19; THENCE ALONG SAID NORTH LINE, N 89°47'37" E, 1311.32 FEET; THENCE CONTINUING ALONG SAID NORTH LINE, N 89°45'53" E, 2622.41 FEET TO THE POINT OF BEGINNING.
