

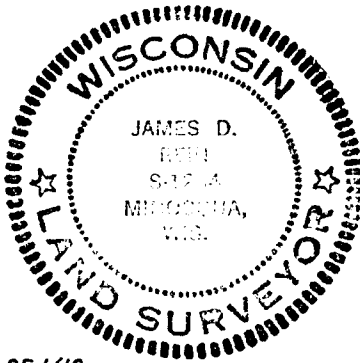
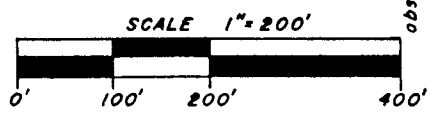

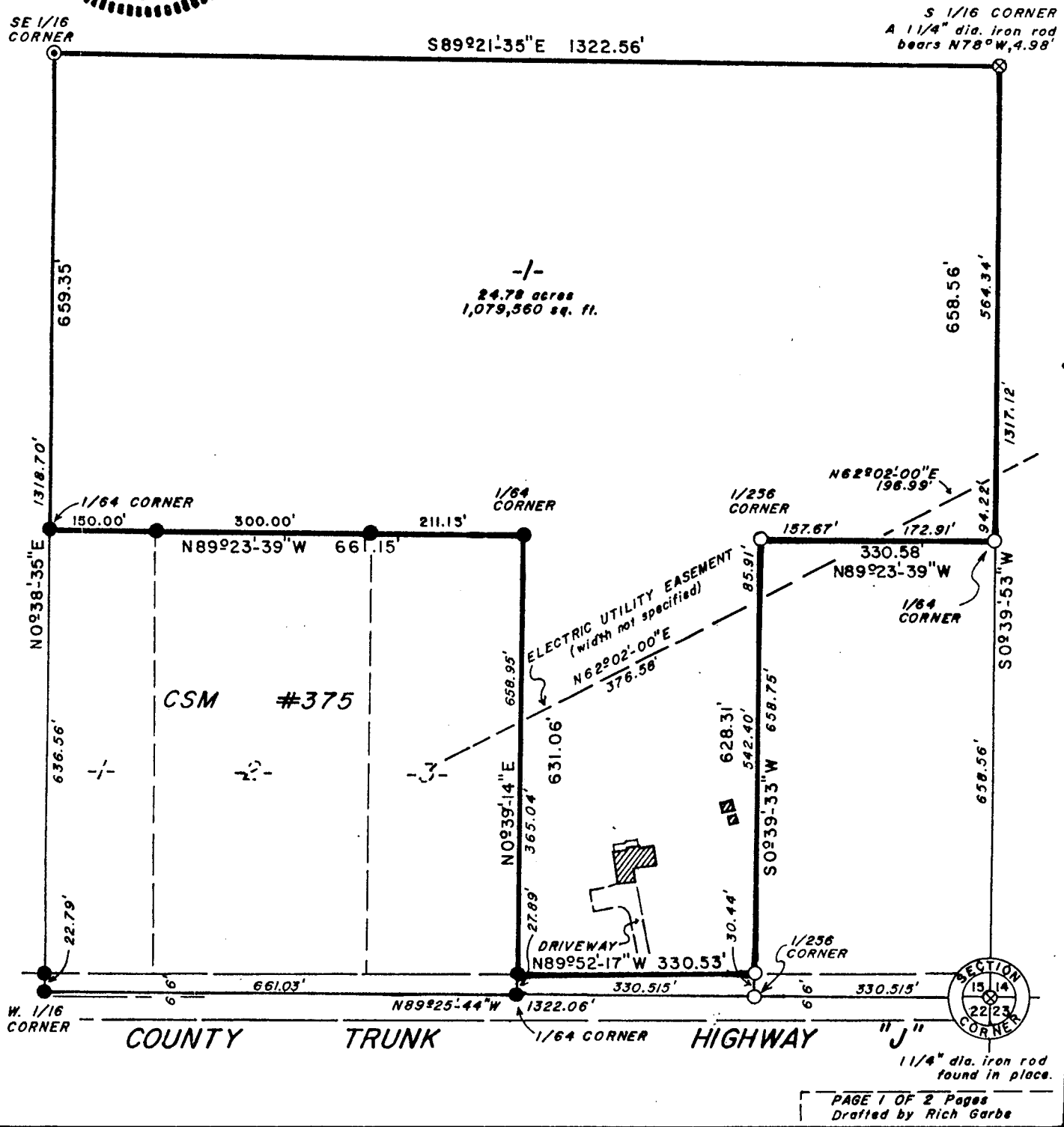

SURVEYOR'S CERTIFICATE

I, JAMES D. REIN, Registered Land Surveyor No. S-1234, hereby certify that by the direction of JOHN L. HAVEMAN, I have surveyed and mapped Lot "1" which is represented by this Certified Survey Map: that the exterior boundary of the parcel of land surveyed and mapped is described as follows:

Lot "1", being the North one-half (N-1/2) of the Southeast one-quarter (SE-1/4) of the Southeast one-quarter (SE-1/4), and part of the West one-half (W-1/2) of the Southeast one-quarter (SE-1/4) of the Southeast one-quarter (SE-1/4) of the Southeast one-quarter (SE-1/4), Section 15, T50N, R4W, Bayfield Township, Bayfield County, Wisconsin, more particularly described as follows:


Commencing at the southeast corner of Section 15 marked by an iron rod in County Trunk Highway "J"; thence N89°-25'-44"W, 661.03 feet along the south line of Section 15 to the 1/64th corner, marked by an iron pipe; thence N0°-39'-14"E, 27.89 feet to the place of beginning marked by an iron pipe on the northerly right-of-way line of County Trunk Highway "J".

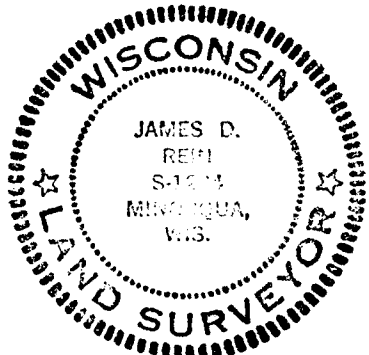
Thence N0°-39'-14"E, 631.06 feet to the 1/64th corner marked by an iron pipe; thence N89°-23'-39"W, 661.15 feet to the 1/64th corner marked by an iron pipe; thence N0°-38'-35"E, 659.35 feet to the 1/16th corner, marked by an iron pipe; thence S89°-21'-35"E, 1322.56 feet to the 1/16th corner marked by an iron rod; thence S0°-39'-53"W, 658.56 feet to the 1/64th corner marked by an iron pipe; thence N89°-23'-39"W, 330.58 feet to the 1/256th corner marked by an iron pipe; thence S0°-39'-33"W, 628.31 feet to an iron pipe on the northerly right-of-way line of County Trunk Highway "J"; thence N89°-52'-17"W, 330.53 feet along said right-of-way line to the place of beginning.

That this Certified Survey Map is a correct representation of the exterior boundary surveyed and described and that I have fully complied with Chapter 236.34 of the Wisconsin Statutes in surveying and mapping same.
