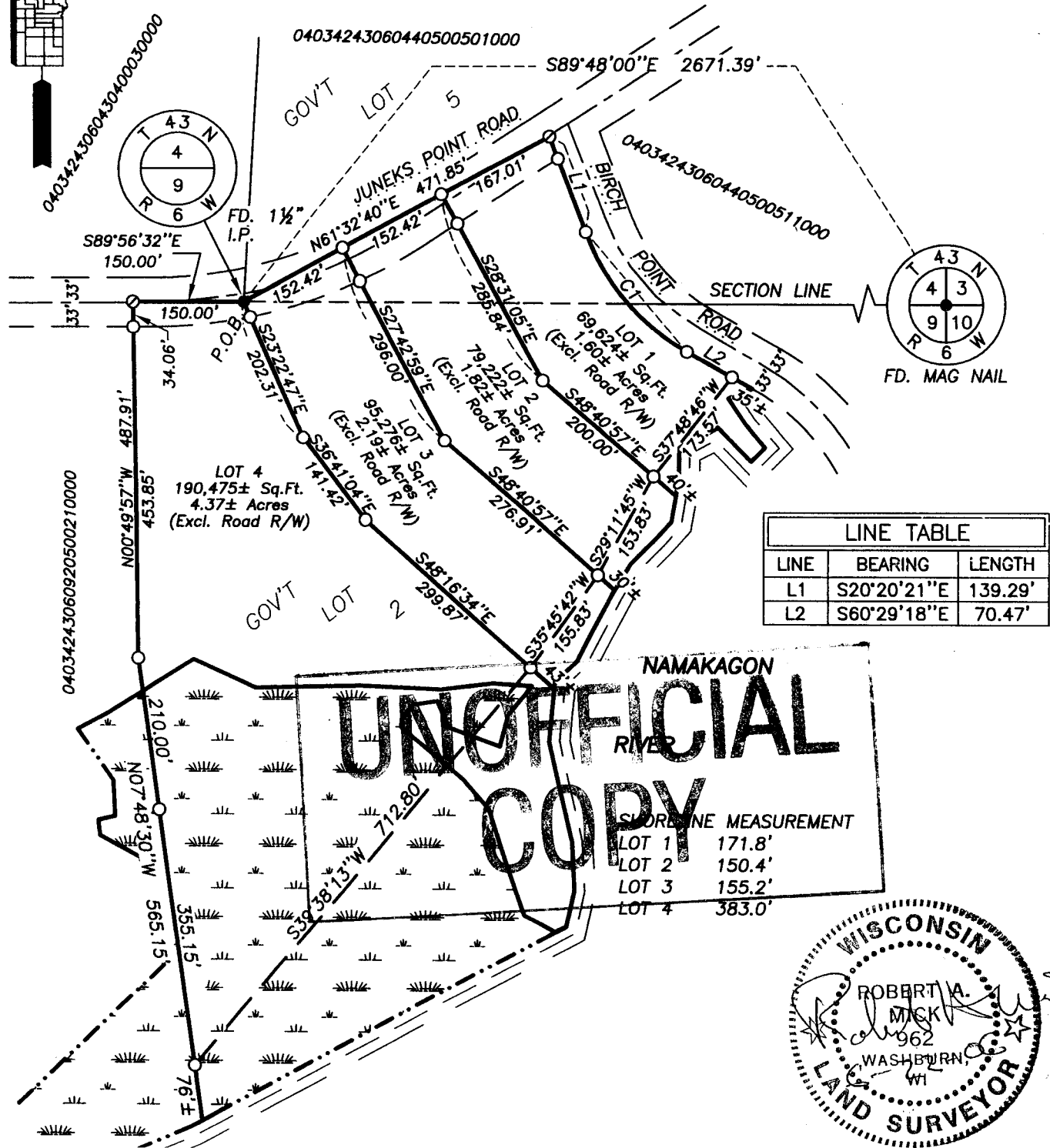
BAYFIELD COUNTY CERTIFIED SURVEY MAP

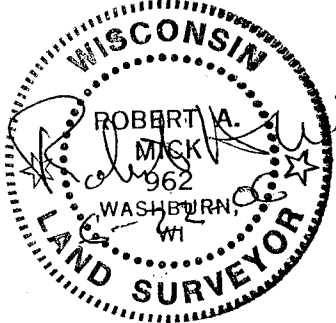

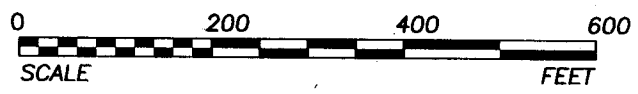

SURVEYOR'S CERTIFICATE

I, Robert A. Mick, Registered Land Surveyor in the State of Wisconsin, hereby certify:

That on the order of David Reichert, agent for the owner, I have surveyed, divided and mapped a parcel of land located in Government Lot 5 of Section 4 and Government Lot 2 of Section 9, all in T. 43 N., R. 6 W., in the Town of Namakagon, Bayfield County, Wisconsin, described as follows:


Beginning at the 1/4 corner common to said Sections 4 and 9, run N 61°32'40" E, 471.85 feet. Thence along the westerly right of way line of Birch Point Road and extension thereof, S 20°20'21" E, 139.29 feet. Thence Southeasterly, 214.95 feet along the arc of a curve to the left, having a radius 306.75 feet, a central angle of 40°08'57" and a chord which bears S 40°24'50" E and measures 210.58 feet. Thence S 60°29'18" E, 70.47 feet to a 3/4" iron rebar meander corner which is N 60°29'18" W, 35 feet, more or less, from the water's edge of the Namakagon River. Thence along a meander line near said water's edge, S 37°48'46" W, 173.57 feet. Thence S 29°11'45" W, 153.83 feet. Thence S 35°45'42" W, 155.83 feet. Thence S 39°38'13" W, 712.80 feet, to a 3/4" iron rebar meander corner which is N 07°48'30" W, 76 feet, more or less, from the water's edge of the Namakagon River. Thence leaving said meander line, N 07°48'30" W, 565.15 feet. Thence N 00°49'57" W, 487.91 feet to the north line of said Section 9. Thence along said north line, S 89°56'32" E, 150.00 feet to the Point of Beginning.

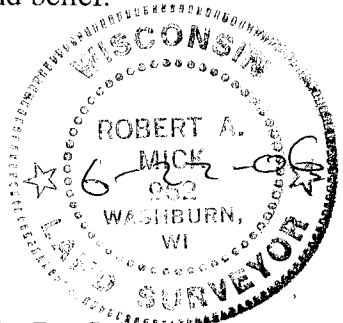
Said parcel contains 434,597 square feet, more or less, which is 9.98 acres, more or less, including that land lying between the meander line and the water's edge of the Namakagon River and the extension of the east and west lot lines to said water's edge and excluding that land lying within the right of way of Junek's Point Road and that river bed lying between the meander line and the water's edge of the Namakagon River.

That this map is a correct representation of said survey and subdivision,


