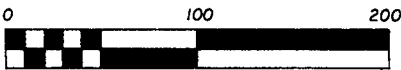

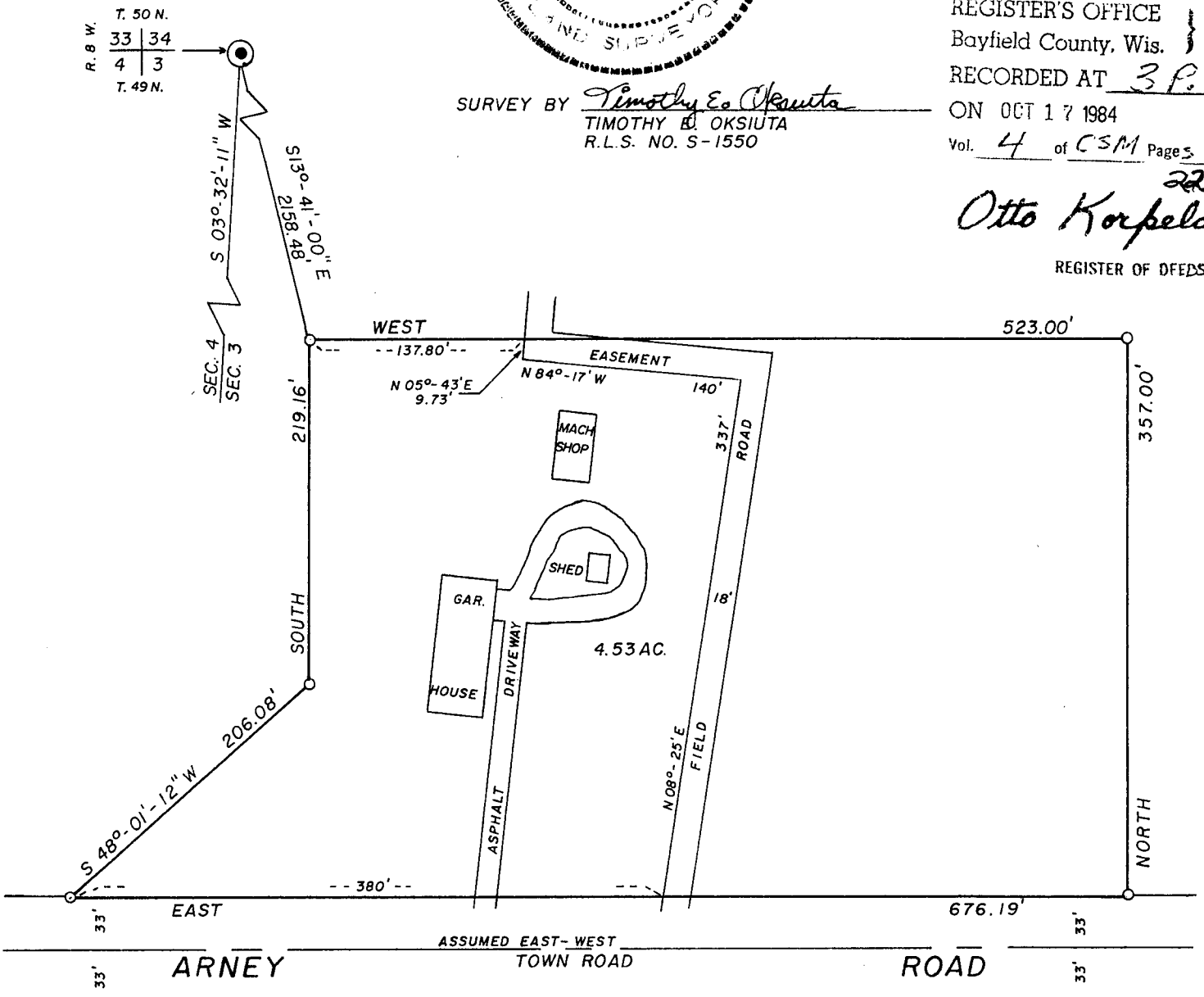

SURVEYOR'S CERTIFICATE

I, Timothy E. Oksiuta, registered land surveyor, hereby certify:

That on the order of Charles Bille, owner, I have made a survey of the following described parcel of land located in the SW 1/4 of the NW 1/4 of Section 3, T. 49 N., R. 8 W., in the Town of Port Wing, Bayfield County, Wisconsin.

To locate the Point of Beginning, commence at the NW corner of said Section 3, and run S 13 -41'-00" E, 2158.48 feet to the point of Beginning.

Thence from said Point of Beginning by metes and bounds:

South, 219.16 feet, perpendicular to the centerline of Arney Road;

Thence S 48 -01'-12" W, 206.08 feet to the north R/W line of Arney Road;

Thence East, 676.19 feet along said north R/W line;

Thence leaving said north R/W line, North, 357.00 feet, perpendicular to the centerline of Arney Road;

Thence West, 523.00 feet, parallel with the centerline of Arney Road, to the Point of Beginning.

Parcel contains 4.53 acres.

The grantor, his heirs and assigns, retain the rights of ingress and egress over and across the existing field road located on the above described parcel of land.

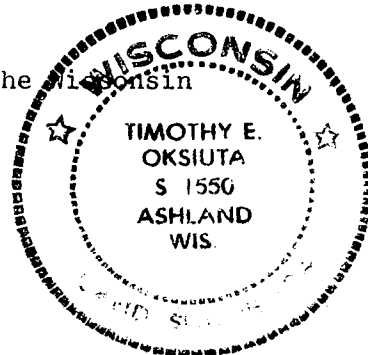


