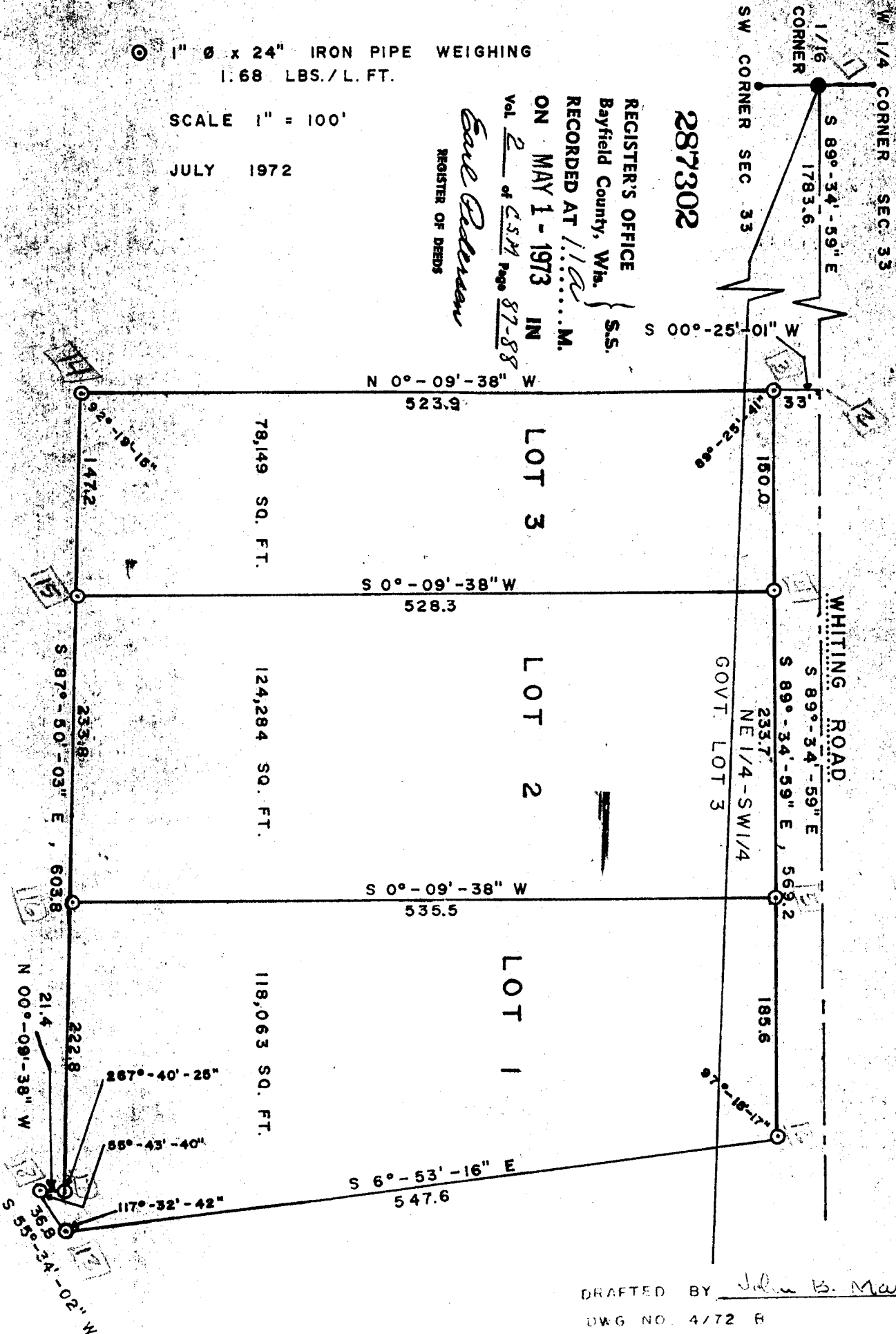

DESCRIPTION

S. 2

A parcel of land situated in parts of Government Lot 3 and the NE 1/4 of the SW 1/4 of Section 33, Township 50 North, Range 4 West, Bayfield County, Wisconsin bounded and described as follows:

Commencing at the West 1/16 corner located between the SW corner and the West 1/4 corner of Section 33; thence S89°-34'-59"E along the centerline of Whiting Road, 1,783.6 feet; thence S00°-25'-01"W, 33.0 feet to a one inch iron pipe, the point of beginning on the southerly right-of-way of Whiting Road;

Thence S89°-34'-59"E along the southerly right-of-way of Whiting Road, 569.2 feet to a one inch iron pipe; thence S6°-53'-16"E, 547.6 feet to a one inch iron pipe on the westerly right-of-way of State Highway 13; thence S55°-34'-02"W along the westerly right-of-way of State Highway 13, 36.8 feet to a one inch iron pipe; thence N00°-09'-38"W, 21.4 feet to a one inch iron pipe; thence N87°-50'-03"W, 603.8 feet to a one inch iron pipe; thence N00°-09'-38"W, 523.9 feet to the point of beginning.

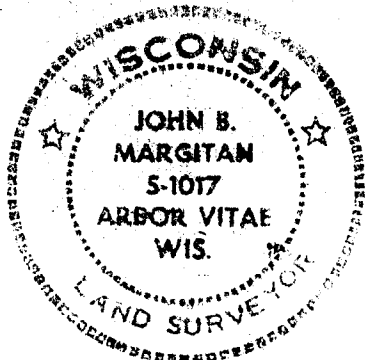
