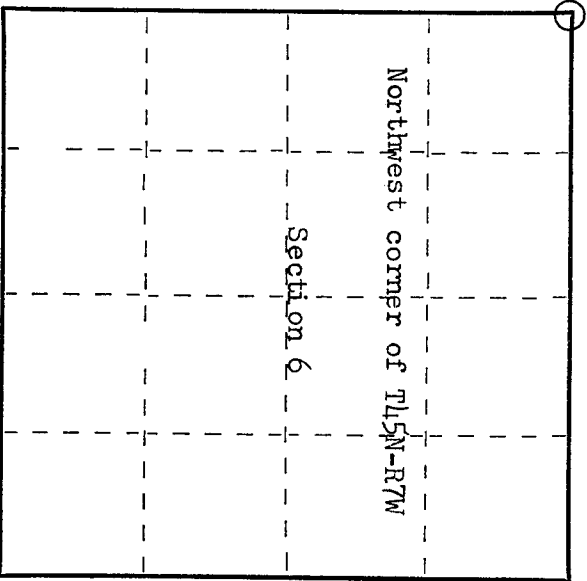

History of original corner establishment: Original corner established in 1858, by Albert C. Stuntz, Government Deputy Surveyor.

Birch	11"	N60W	34	links.
Birch	10"	S30W	36	links.
Sugar	7"	S12E	42	links.
Maple	10"	N70E	38	links.

Description of corner evidence found: Corner marked by a 3" iron pipe, set 12" above ground, fitted with a 4" iron cap stamped: 1, 6, 31, 36. This monument was set at the original corner location by Jerod Day, Surveyor, in 1920. He stated, in his re-survey of record, that he found both original Birch bearing trees. I found no evidence of these trees as both were destroyed during construction of a bulldozed road.

Description of monument and accessories I established to perpetuate the original location of this corner.

Set a 2" inside diameter, 5 foot long, flanged bottom, galvanized wrought iron pipe, filled with concrete, capped with a 3" bronze tablet stamped: T45N, T46N, R7W, R8W, 1,6,31,36, S.212, 1960.

Blazed and scribed the following new bearing trees:

- Hem. 11" N82°30'E 52.3 feet.
- Oak 8" S27°30'E ~~XXX~~ 45.8 feet.
- Oak 7" N80°W 73.3 feet.

Nailed metal location tag on a 9" Oak which brs. N3°W, 28.5' from corner. Set cedar post, with top painted red, at monument.
