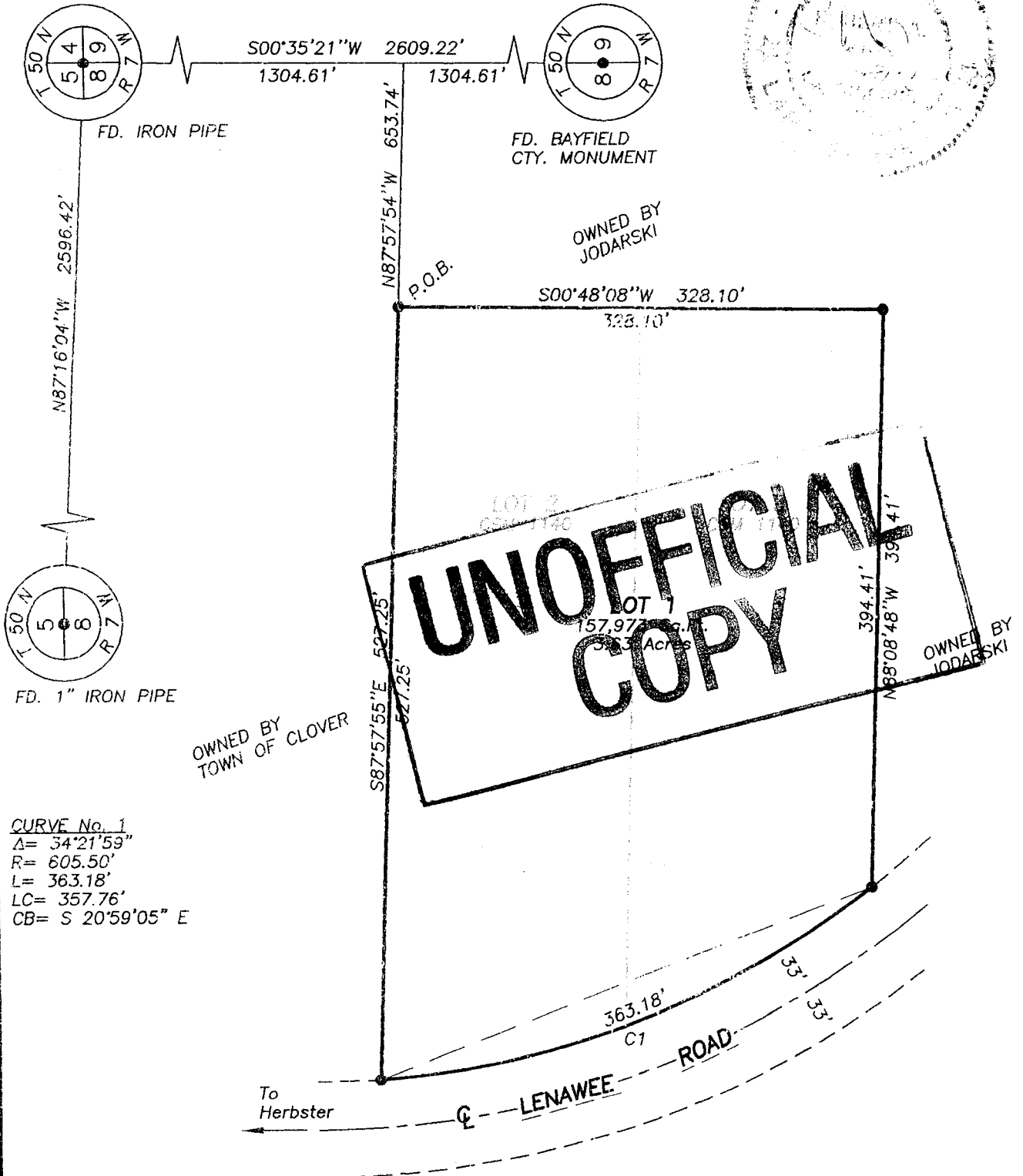


BAYFIELD COUNTY CERTIFIED SURVEY MAP

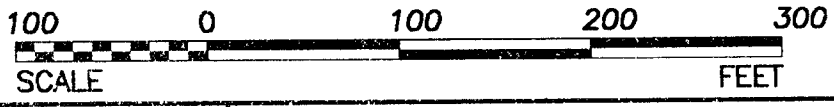
LOTS 2&3 OF BAYFIELD CO. CSM #1140

I, Robert A. Mick, Registered Land Surveyor in the State of Wisconsin, hereby certify:


That on the order of PAT MURPHY, I have surveyed and mapped the following parcel being Lots 2 & 3 of Bayfield Co. CSM #1140, located in the SE ¼ of the NE ¼, Section 8, T50N, R7W, Town of Clover, Bayfield County, WI, described as:

Commencing at the corner common to Sections 4, 5, 8 & 9, T50N, R7W; thence S00°35'21"W 1304.61 feet along the line common to Sections 4, 5, 8 & 9; thence N87°57'54"W 653.74 feet to the POINT OF BEGINNING; thence S09°43'19"W 328.10 feet; thence N88°08'48"W 391.41 feet to an iron rod located on the Easterly right-of-way of Lenawee Road; thence along said right-of-way on a curve to the right having a radius of 605.50 feet, a long chord bearing and distance of N20°59'09"W 357.76 feet, 363.18 feet; thence S87°57'55"E 527.25 feet to the POINT OF BEGINNING; containing 157,972 square feet, which is 3.63 acres, and is subject to any easements of record.

That I have fully complied with Section 236.34 of the Wisconsin Statutes and the Bayfield County Subdivision Control Ordinance in making the same; and


