

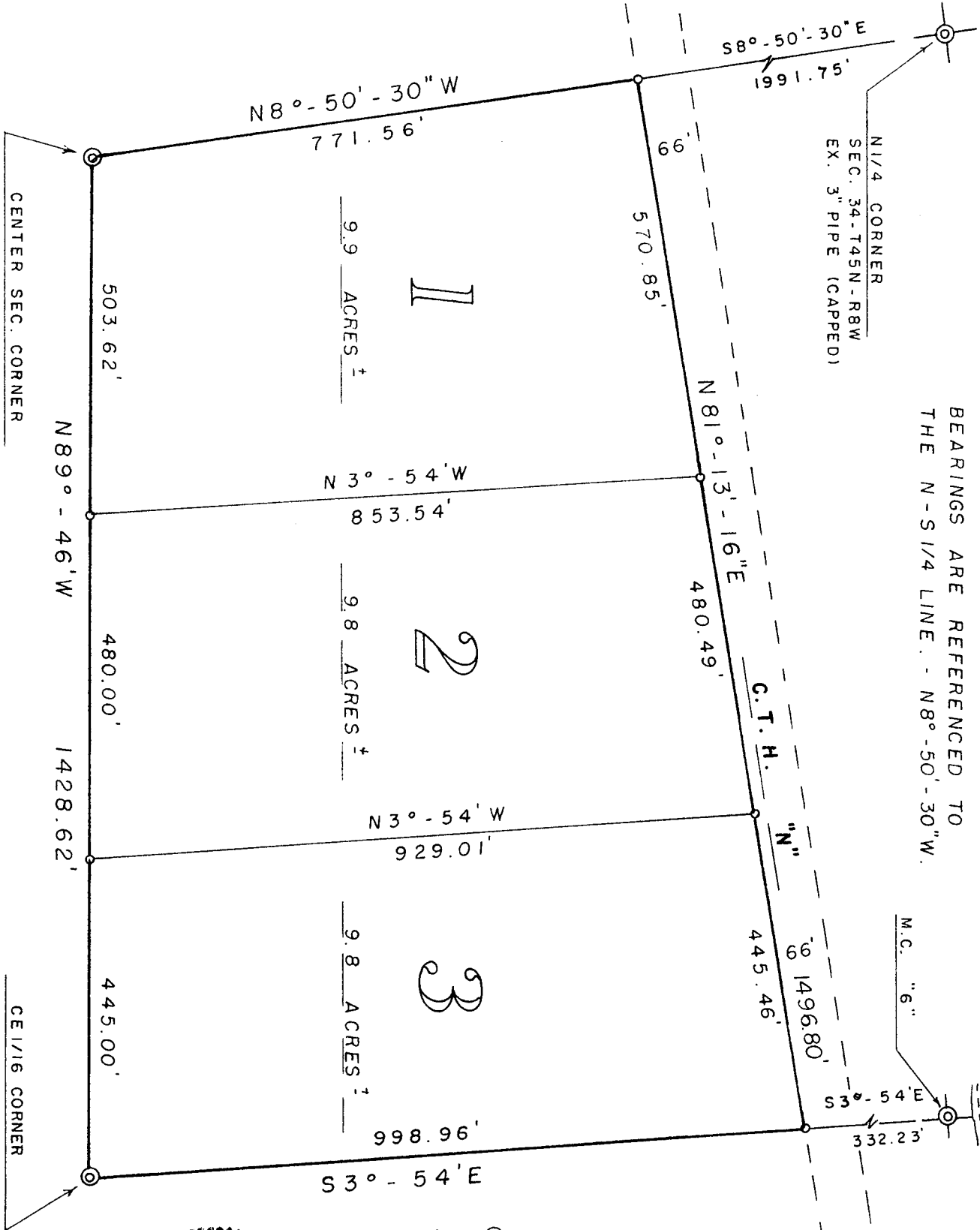

PLAT OF SURVEY

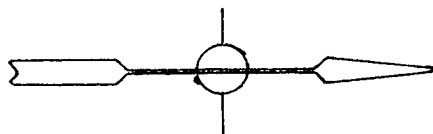

PIGEON LAKE

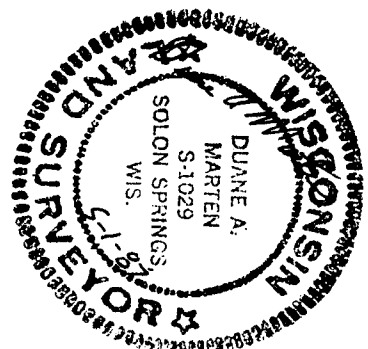
BEARINGS ARE REFERENCED TO THE N-S 1/4 LINE -  $N 8^{\circ} - 50' - 30'' W$ .

Commencing at the N $\frac{1}{2}$  corner of said Sec. 34; thence S80°-50'-30"E, along the N-S $\frac{1}{4}$  line, 1991.75 feet to the South line of C.T.H. "N" and the point of beginning; thence N81°-13'-16"E, along said South line, 570.85 feet; thence S30°-54'E, 853.54 feet to the South line of G.L. 6; thence N89°-46'W along said South line, 503.62 feet to the center corner of Sec. 34; thence N80°-50'-30"W along the N-S $\frac{1}{4}$  line, 771.56 feet to the South line of C.T.H. "N" and the point of beginning. Said parcel contains 9.9 acres of land, more or less. Subject to all easements and reservations of record.

Lot 6, 445.00 feet; thence N30°-54'W, 929.01 feet to the South line of C.T.H. "N" and the point of beginning. Said parcel contains 9.8 acres of land, more or less. 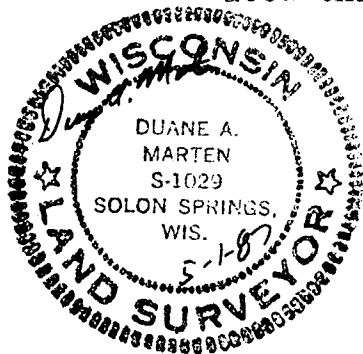
