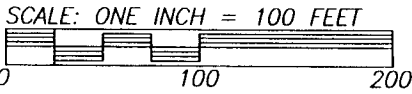

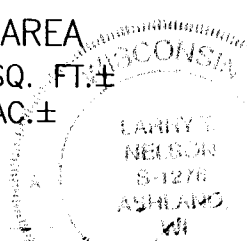

THAT ON THE ORDER OF ALICE RACHER, I HAVE SURVEYED, DIVIDED AND MAPPED THE FOLLOWING DESCRIBED PARCEL OF LAND, LOCATED IN PART OF GOV'T. LOT 1, SECTION 8, T. 43 N., R. 8 W., AND PART OF GOV'T. LOT 2, SECTION 7, T. 43 N., R. 7 W., ALL IN THE TOWN OF CABLE, BAYFIELD COUNTY, WISCONSIN;

TO LOCATE THE POINT OF BEGINNING COMMENCE AT THE NW CORNER OF SAID SECTION 7 AND RUN, S 00°19'13" W, 1311.64 FEET, ALONG THE WEST LINE OF SAID SECTION 7, TO THE NW CORNER OF GOV'T. LOT 2, SECTION 7, T. 43 N., R. 7 W., AND THE POINT OF BEGINNING;

THENCE FROM SAID POINT OF BEGINNING BY METES AND BOUNDS:

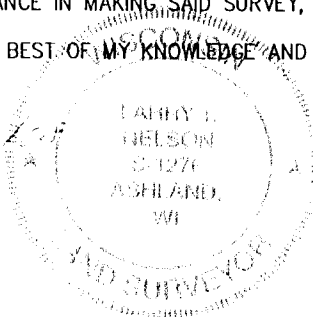
