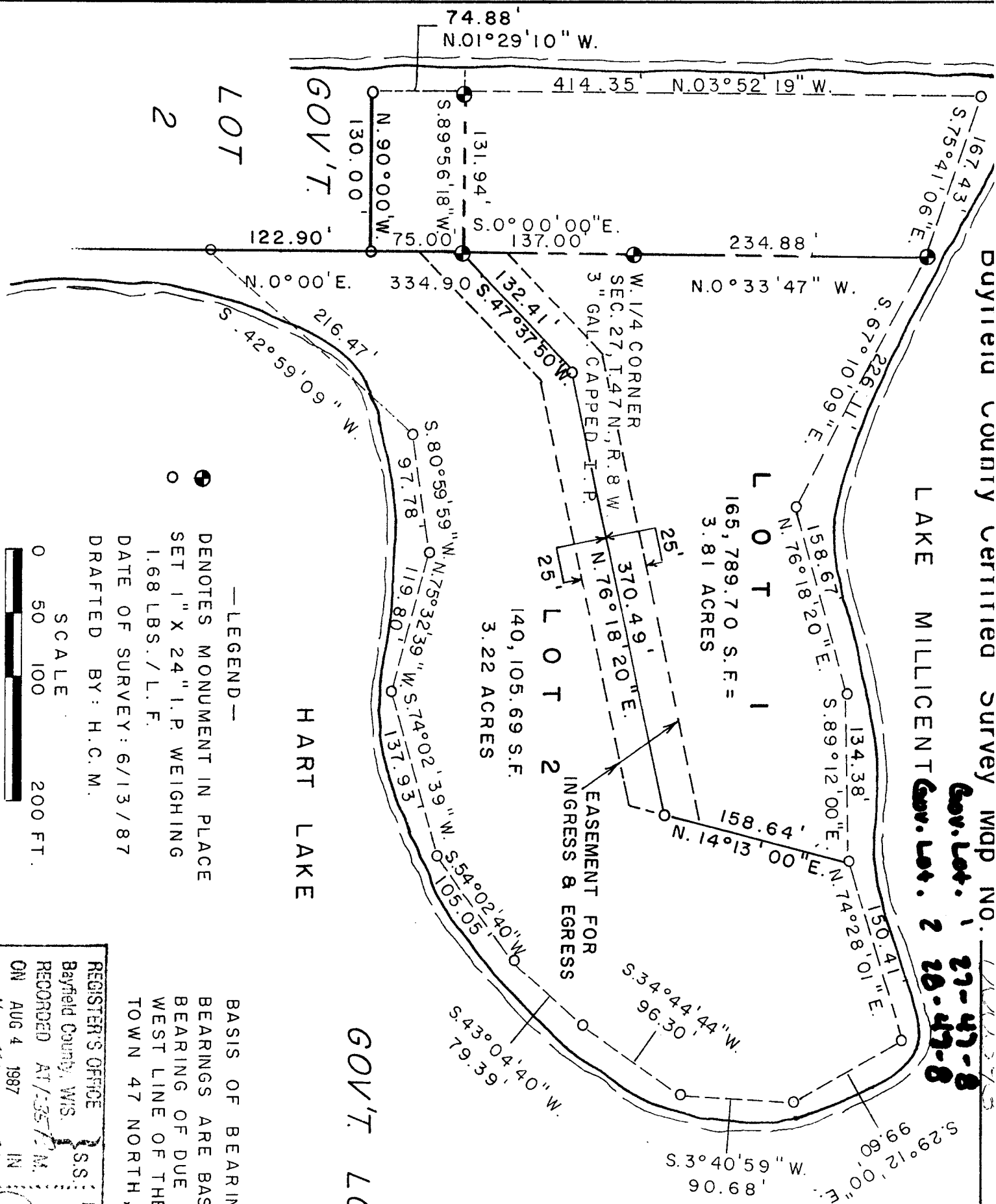

LAKE MILLICENT Gov. Lot. 2



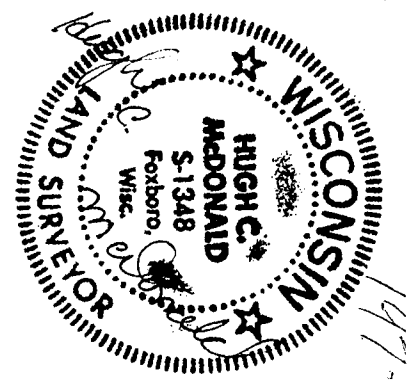

Surveyors Certificate

I Hugh C. McDonald, Registered Land Surveyor, hereby certify that I have surveyed, divided and mapped a parcel of land located in Government Lot 1, Section 27, T14N R17W Range 1 West, and Government Lot 2, Section 28, T14N R17W Range 1 West, Town of Iron River, Bayfield County Wisconsin, more particularly described as follows:

Commencing at the east One-Quarter Corner of section 27, the same being marked by a 2" galvanized capped iron pipe, thence S. 00 degrees 00 minutes 20 seconds E. 197.00 feet to a 3" capped iron pipe, thence continuing S. 00 degrees 00 minutes 00 seconds E. 70.00 feet to the place of beginning, thence N. 80 degrees 00 minutes 00 seconds W. 130.00 feet and the place of beginning of the meander line, thence N. 01 degrees 28 minutes 13 seconds W. 71.20 feet to a 3" capped iron pipe, thence N. 03 degrees 52 minutes 19 seconds W. 414.25 feet, thence S. 78 degrees 41 minutes 06 seconds E. 167.43 feet, to a 3" galvanized capped iron pipe, thence S. 67 degrees 10 minutes 08 seconds E. 126.11 feet, thence N. 75 degrees 18 minutes 20 seconds E. 189.67 feet, thence S. 65 degrees 12 minutes 00 seconds E. 134.23 feet, thence N. 71 degrees 28 minutes 01 seconds E. 150.41 feet, thence S. 28 degrees 12 minutes 00 seconds E. 96.60 feet, thence S. 08 degrees 40 minutes 53 seconds W. 90.66 feet, thence S. 04 degrees 44 minutes 44 seconds W. 26.30 feet, thence S. 48 degrees 04 minutes 10 seconds W. 79.28 feet, thence S. 54 degrees 02 minutes 40 seconds W. 105.05 feet, thence S. 74 degrees 02 minutes 39 seconds W. 137.33 feet, thence N. 75 degrees 02 minutes 29 seconds W. 111.00 feet, thence S. 60 degrees 59 minutes 59 seconds W. 67.78 feet, thence S. 42 minutes 59 minutes 09 seconds W. 216.47 feet to a point on the east line of section 27, thence N. 00 degrees 10 minutes 00 seconds E. 122.30 feet to the place of beginning.
