SURVEYOR'S CERTIFICATE:

I, Duane A. Marten, Registered Land Surveyor, hereby certify:

That I have surveyed, divided and mapped that part of the NE $\frac{1}{4}$ -SW $\frac{1}{4}$  and NW $\frac{1}{4}$ -SE $\frac{1}{4}$ , Sec. 16-T44N-R9W, Town of Barnes, Bayfield County, Wisconsin, bounded and described as follows:

That such plat is a correct representation of all exterior boundaries of the land surveyed and the subdivision thereof made.

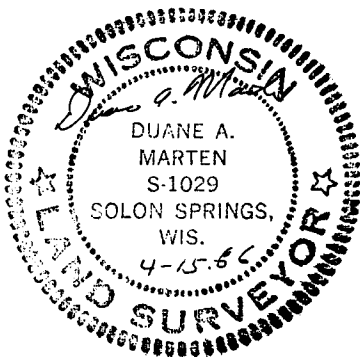
