I Randy R. Erickson, do hereby certify that on the 31 st day of July, 15 2002, I found evidence of the Township corner of Sections 1-6-31-36 Township 48 and 49 North, Range 6 and 7 West, Fourth Principal Meridian, as described hereon; and that from this evidence I established a new monument and accessories as described hereon to perpetuate the original location of this corner:

Description of original monument and accessories and subsequent restorations:

- 1852 Elijah S. Norris set a wood post and marked bearing Trees:
Wh. Pine 12" S 55 W 12 links Red Pine 20" N 05 W 67 links
Wh. Pine 10" N 20 E 10 links Red Pine 15" S 71 E 58 links
- 1933 U.S.G.L.O. dependant resurvey. Found remains of original bearing trees. At point for corner set a concrete monument in the form of a frustrum of a cone, 8" upper dia., 13" lower dia. standing 30" above ground, with a rectangular base 24"x24"x24" top level with ground surface. In top of frustrum set a 3 1/2" brass tablet stamped to identify corner. REMAINS of original Bearing trees:
Wh. pine stump 12" S 55 W 12 link, Norway pine 20" N 17 W 61 links
Norway stump differs from record. No new trees available.

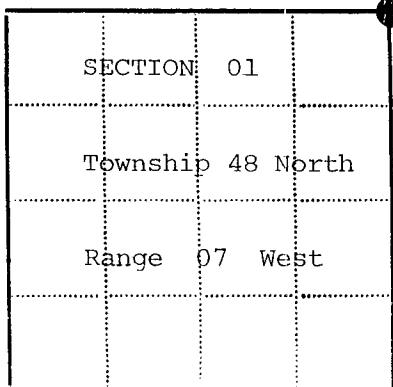
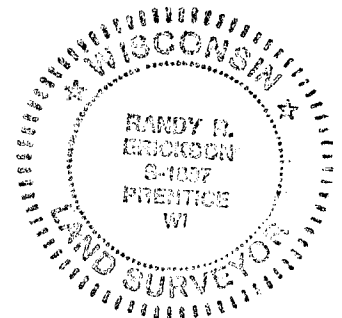
- 2002 Found concrete frustrum with brass cap in place.
