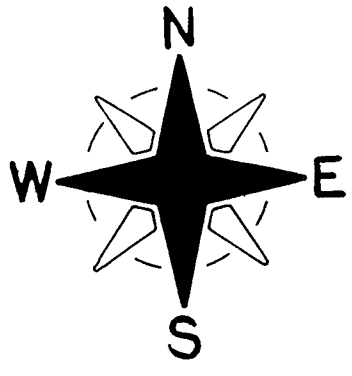
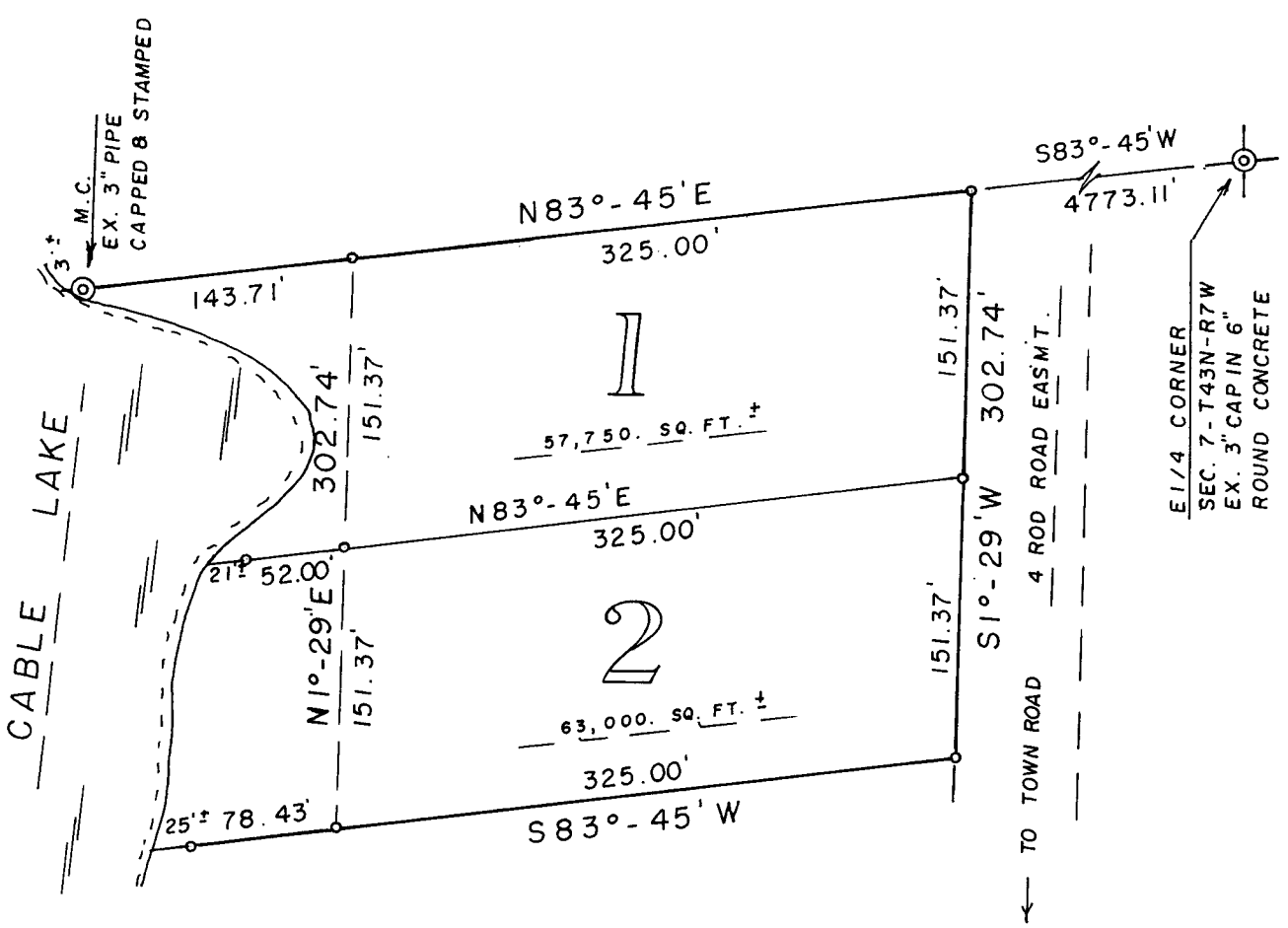

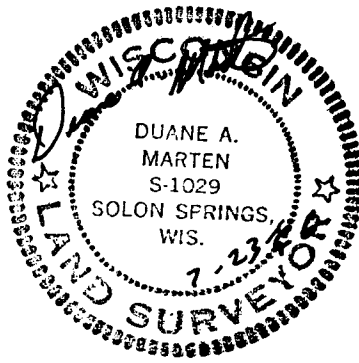

SURVEYOR'S CERTIFICATE:

I, Duane A. Marten, Registered Land Surveyor, hereby certify:

That I have surveyed, divided and mapped that part of Gov't. Lot 1, Sec. 7-T43N-R7W, Town of Cable, Bayfield County, Wisconsin, bounded and described as follows:

Commencing at the E $\frac{1}{2}$  corner of said Sec. 7; thence S83°-45'W along the E-W  $\frac{1}{4}$  line, 4773.11 feet to the point of beginning; thence S1°-29'W, 302.74 feet; thence S83°-45'W, 325.00 feet to a point 103 feet, more or less, from the water's edge of Cable Lake; thence N1°-29'E along a meanderline, 302.74 feet to a point 147 feet, more or less, from the water's edge of Cable Lake; thence N83°-45'E along the E-W $\frac{1}{4}$  line, 325.00 feet to the point of beginning. Including all lands lying between the above described meanderline and the respective lot lines extended to the water's edge of Cable Lake. Subject to all easements and reservations of record. A 4 rod ingress-egress easement to be provided along and from the Easterly boundary of the above described parcel Southerly to the Town Road.

That such plat is a correct representation of all exterior boundaries of the land surveyed and the subdivision made.

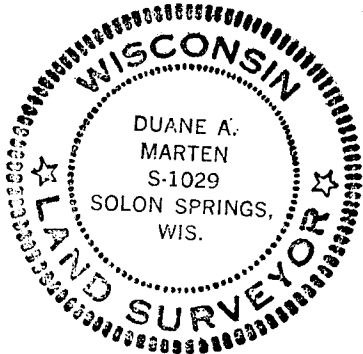
