I Randy R. Erickson, do hereby certify that on the 15 th day of July, 20 03, I found evidence of the Town ship corner corner of Sections 1,6,31,36, Townships 49 and 50 North, Range 05 and 06 West, Fourth Principal Meridian, as described hereon; and that from this evidence I established a new monument and accessories as described hereon to perpetuate the original location of this corner.

Description of Original monument and accessories and subsequent restorations:

1852 Elisha S. Norris, set a wood post and marked bearing trees:  
Red Pine 15" N 30 W 62 links Red Pine 14" N 40 E 50 links  
Red Pine 10" S 50 E 47 links Red Pine 12" S 11 W 24 links

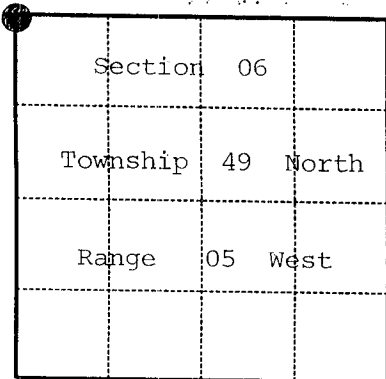
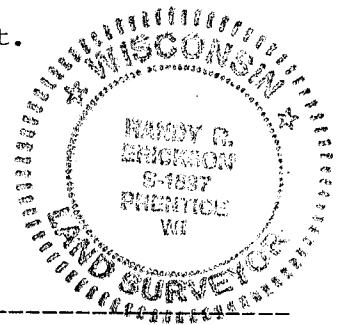
1934 U.S. General Land Office dependent resurvey of T 49 N, R 06 W. Determined point of corner from remains of original bearing trees. Set an iron post, 3 feet long, 1" dia. in a cylindrical concrete form 3 feet long, 10" dia., 26 inches in the ground, with a brass cap stamped to identify the corner. Raise a mound of stone 3 ft. base 1.5 feet high on West side of corner.

Description of corner evidence found:

Found 1934 GLO monument and Mound of stone in place. Found remains of original Red Pine Stump S 11 W 24 link.

Description of monument and accessories I established to perpetuate the location of this corner:

Left 1934 monument in place; Marked new Bearing Trees:  
Oak 4" S 18 E 5.78 ft. Oak 6" S 50 W 7.90 ft.  
Oak 11" N 31 E 11.60 ft. Steel Sign Post East 1.1 ft.
