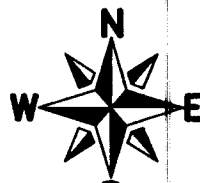
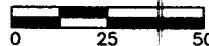


# BAYFIELD COUNTY PLAT OF SURVEY

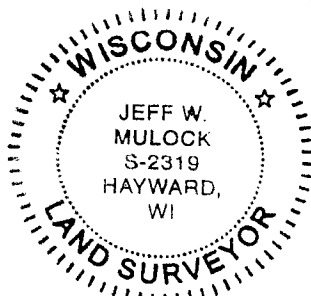
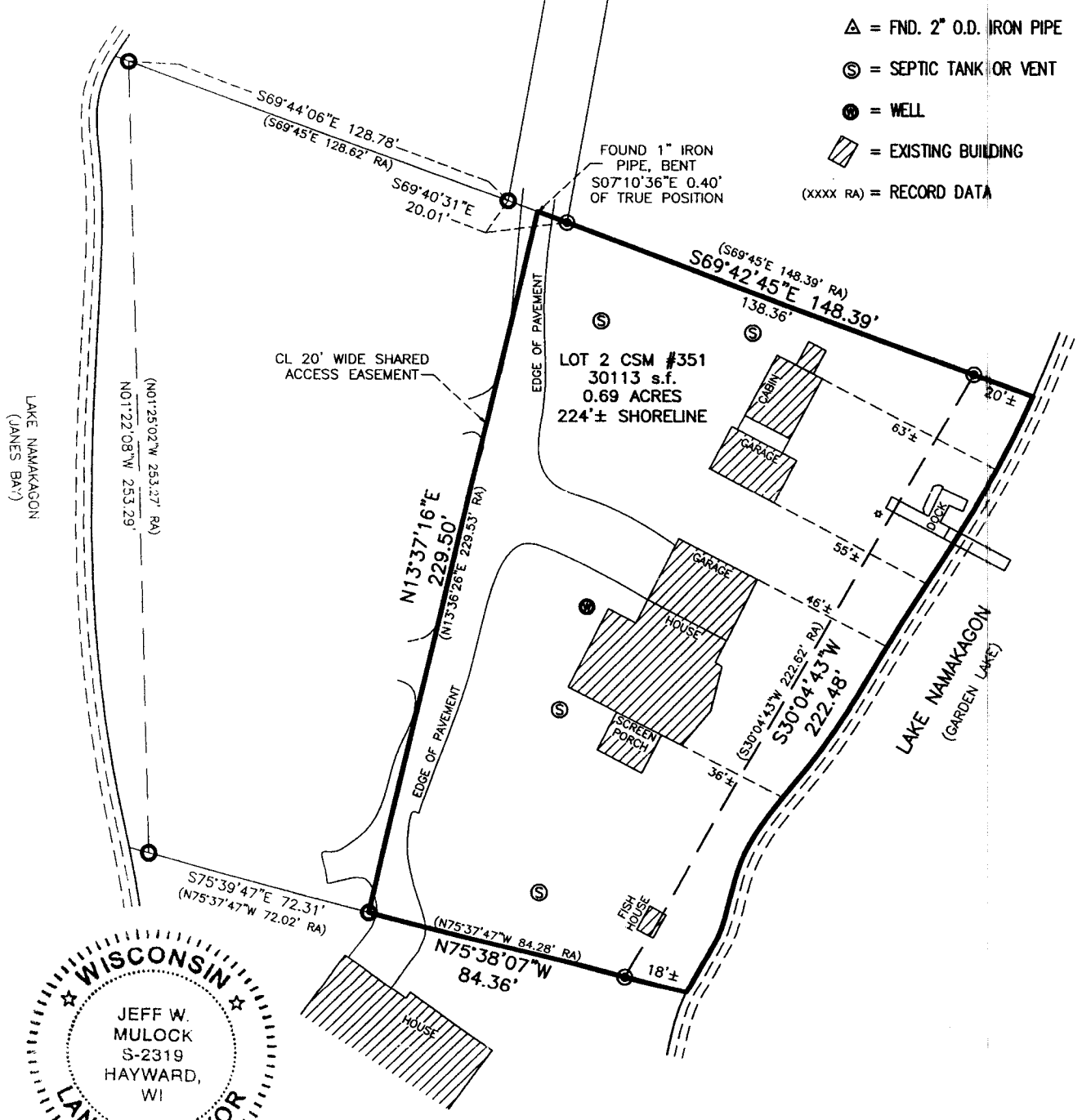
