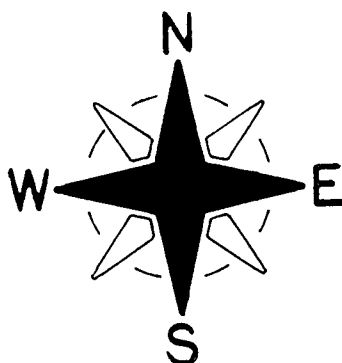
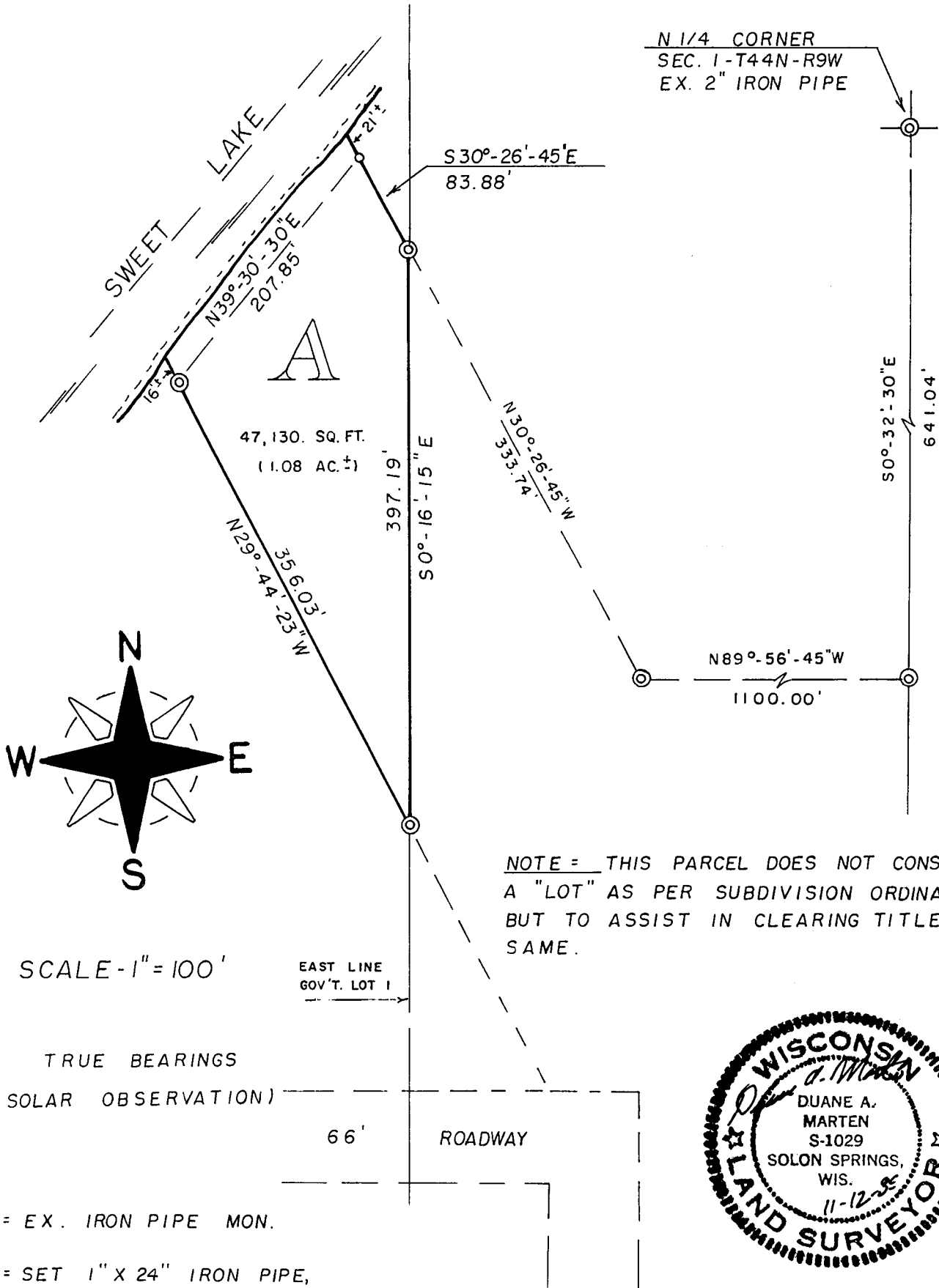

SURVEYOR'S CERTIFICATE:

I, Duane A. Marten, Registered Land Surveyor, hereby certify:

That I have surveyed, and mapped that part of Gov't. Lot 1, Sec. 1-T44N-R9W, Town of Barnes, Bayfield County, Wisconsin, bounded and described as follows:

Commencing at the N $\frac{1}{4}$ corner of said Sec. 1; thence S0 $^{\circ}$ -32'-30"E along the N-S $\frac{1}{4}$ line of said Sec. 1, 641.04 feet; thence N89 $^{\circ}$ -56'-45"W, 1100.00 feet; thence N30 $^{\circ}$ -26'-45"W, 333.74 feet to the East line of Gov't. Lot 1 and the point of beginning; thence S0 $^{\circ}$ -16'-15"E along said East line, 397.19 feet; thence N29 $^{\circ}$ -44'-23"W, 356.03 feet to a point 16 feet, more or less, from the water's edge of Sweet Lake; thence N39 $^{\circ}$ -30'-30"E along a meanderline, 207.85 feet to a point 21 feet, more or less, from the water's edge of Sweet Lake; thence S30 $^{\circ}$ -26'-45"E, 83.88 feet to the East line of Gov't. Lot 1 and the point of beginning. Including all lands lying between the above described meanderline and the water's edge of Sweet Lake. Subject to all easements and reservations of record.
