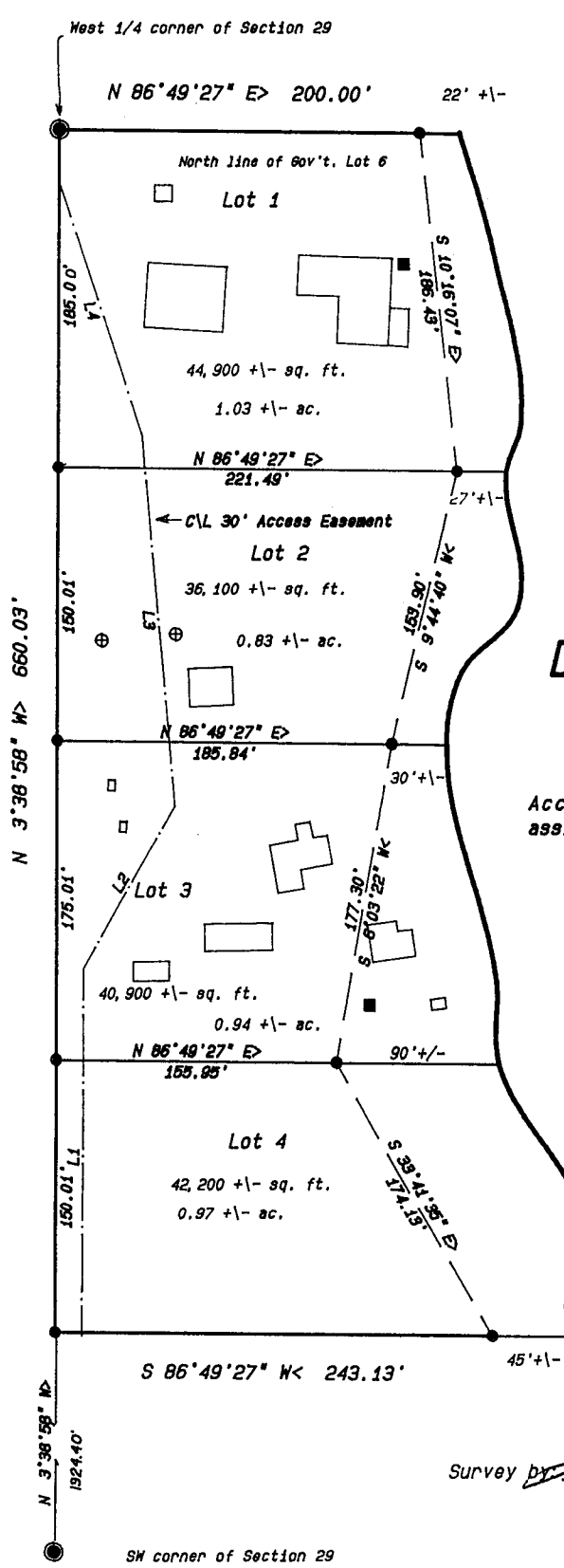

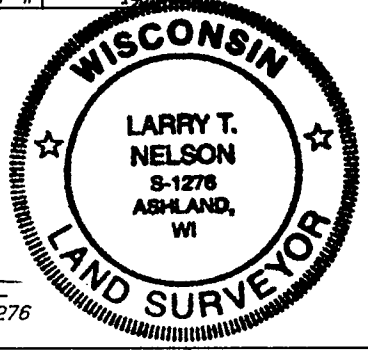

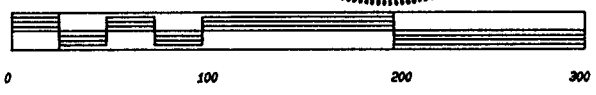

SURVEYOR'S CERTIFICATE

I, Larry T. Nelson, registered land surveyor in the State of Wisconsin, hereby certify:

That on the order of Alice Kimball, I have surveyed, divided and mapped the following described parcel of land located in Government Lot 6, Section 29, T. 44 N., R. 6 W., in the Town of Grand View, Bayfield County, Wisconsin;

To locate the Point of Beginning, commence at the West 1/4 corner of said Section 29, and run S 03°38'58" E, 660.03, along the West line of said Section 29 to the Point of Beginning.

Thence from said Point of Beginning by metes and bounds:

Continue S 03°38'58" E, 634.19 feet to the southwest corner of said Government Lot 6; Thence along the south line of said Government Lot 6, N 07°07'16" E, 660.21 feet; Thence leaving said south line, N 03°38'57" W, 496.73 feet to a meander corner near the westerly water's edge of Diamond Lake; Thence along a meander line near said water's edge; N 74°08'35" W, 431.82 feet; Thence leaving said meander line, S 86°49'27" W, 243.13 feet to the west line of said Section 29 and the Point of Beginning. Parcel contains 388,000 +/- square feet which is 8.9 +/- acres and includes that land lying between the meander line and the water's edge of Diamond Lake and the extensions of the parcel lines to said water's edge.
