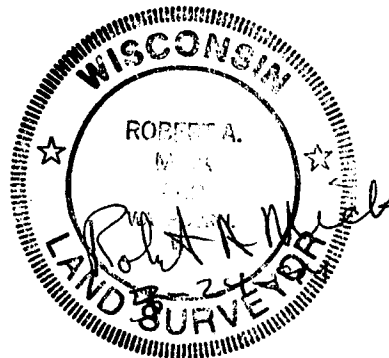

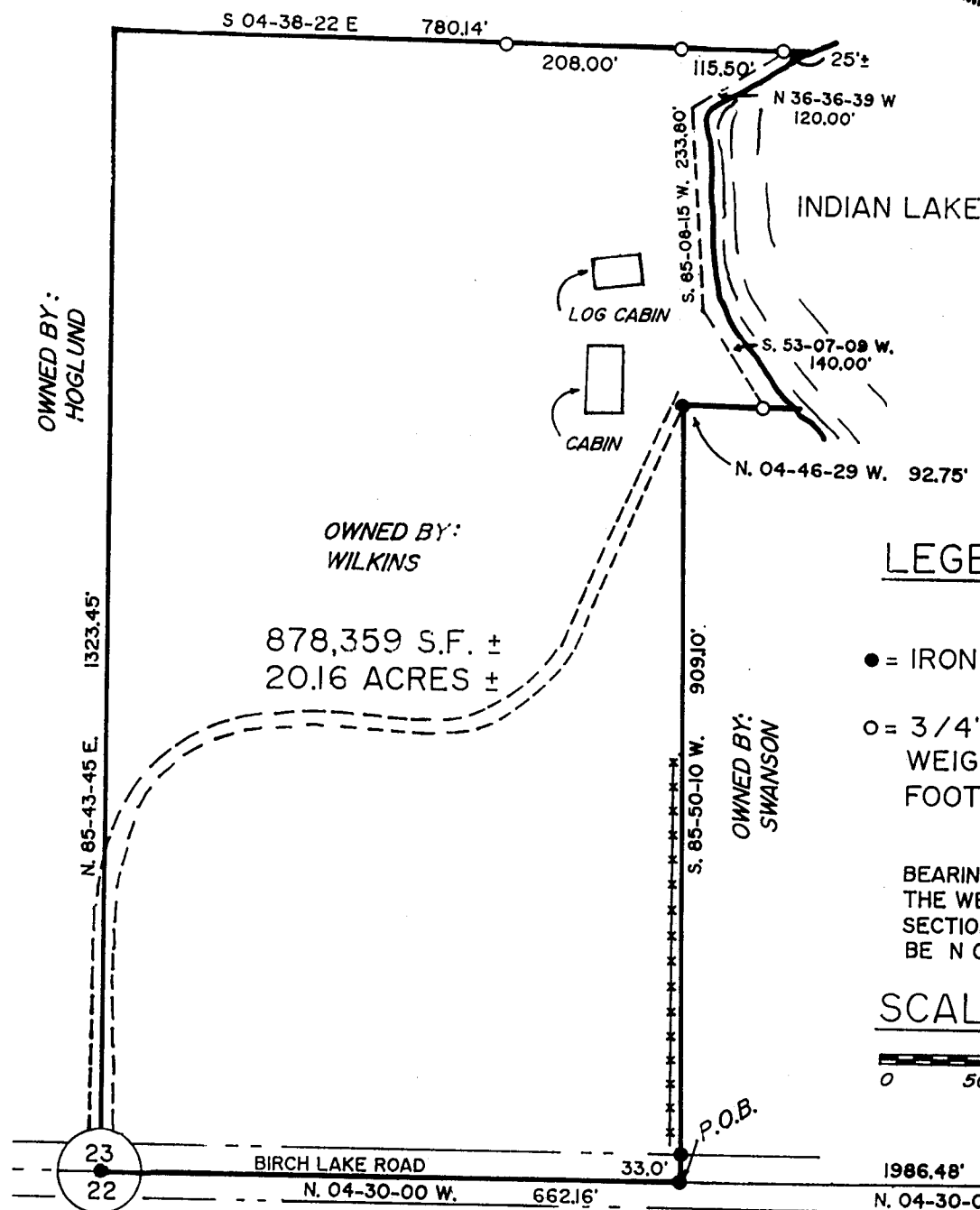

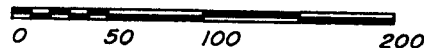

BAYFIELD COUNTY CERTIFIED SURVEY MAP NO. 000785

A parcel of land located in the NW $\frac{1}{4}$  of the SW $\frac{1}{4}$ , Section 23, T45N, R5W, Lincoln Township, Bayfield County, Wisconsin, described as:

Commencing at a corner common to Sections 22, 23, 26 and 27; thence N04°30'00"W 1986.48 feet along a line common to Sections 22 and 23 to the point of beginning; thence N04°30'00"W 662.16 feet along a line common to Sections 22 and 23 to a point which is the quarter corner common to Sections 22 and 23; thence N85°43'45"E 1323.45 feet; thence S04°38'22"E 780.14 feet to an iron rod located near the shore of Indian Lake which is the point of beginning of a meander line to Indian Lake; said line also continues S04°38'22"E to the water's edge. Thence along said meander line N36°36'39"W 120.00 feet; thence along said meander line S85°08'15"W 233.80 feet; thence along said meander line S53°07'09"W 140.00 feet to an iron rod which is the point of ending of said meander line; thence N04°46'29"W 92.75 feet to an iron rod; said line also continues S04°46'29"E to the water' edge. Thence S85°50'10"W 909.10 feet to an iron rod located in the center of Birch Lake Road which is the point of beginning.

The above-described parcel contains 878,359 square feet, more or less, which is 20.16 acres, more or less, and is subject to roadway and any other easements of record.
