I, Duane A. Marten, Registered Land Surveyor, hereby certify:

That I have surveyed and mapped that part of Gov't. Lot 2, Sec. 20-T44N-R9W, Town of Barnes, Bayfield County, Wisconsin, bounded and described as follows:

Parcel "A"

Commencing at the E $\frac{1}{4}$  corner of said Sec. 20; thence N88°-27'W along the E-W $\frac{1}{4}$  line, 1243.19 feet; thence N0°-00'-54"W along the East line of Gov't. Lot 2, 631.09 feet; thence N86°-21'-30"W, 81.17 feet; thence N61°-15'W, 217.15 feet; thence N1°-35'W, 99.30 feet; thence N33°-29'W, 110.00 feet to the point of beginning; thence N86°-04'-30"W, 176.10 feet to a point 4 feet, more or less, from the water's edge of Middle Eau Claire Lake; thence N43°-31'-50"E along a meanderline, 120.08 feet to a point 25 feet, more or less, from the water's edge of Middle Eau Claire Lake; thence S43°-10'E, 135.90 feet to the point of beginning. Including all lands lying between the above described meanderline and the water's edge of Middle Eau Claire Lake. Subject to all easements and reservations of record.

Parcel "B"

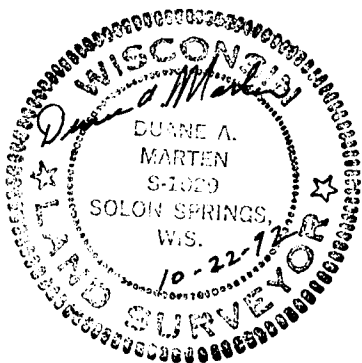

Lot 2, 631.09 feet; thence N86°-21'-30"W, 81.17 feet; thence N61°-15'W, 217.15 feet; thence N1°-35'W, 99.30 feet; thence N33°-29'W, 110.00 feet to the point of beginning; thence N43°-10'W, 135.90 feet to a point 25 feet, more or less, from the water's edge of Middle Eau Claire Lake; thence N52°-27'-06"E, along a meanderline, 116.30 feet to a point 10 feet, more or less, from the water's edge of Middle Eau Claire Lake; thence S0°-15'-30"E, 170.00 feet to the point of beginning. Including all lands lying between the above described meanderline and the water's edge of Middle Eau Claire Lake. Subject to all easements and reservations of record.

That such plat is a correct representation of all exterior boundaries of the land surveyed and the subdivision thereof made.
