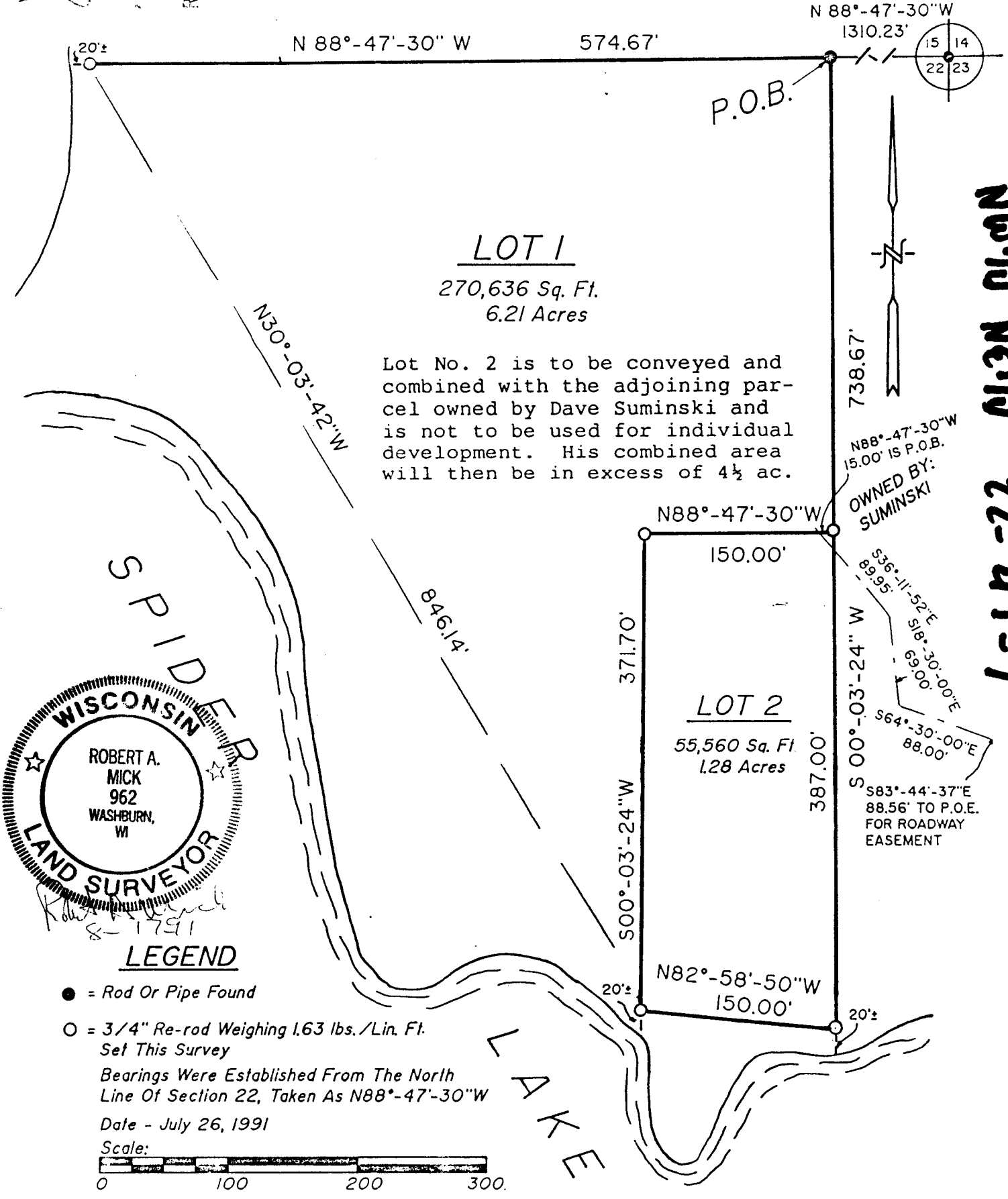

Legal Description

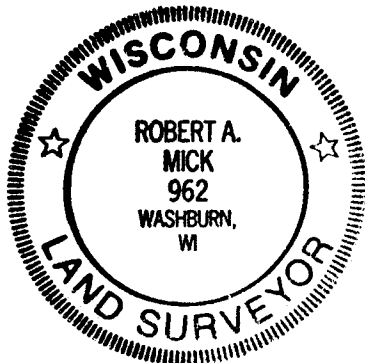
A parcel of land located in the NW 1/4 of the NE 1/4, Section 22, T47N, R7W, Keystone Township, Bayfield County, WI, described as:

Commencing at the corner common to Sections 14, 15, 22 and 23; thence N88°47'30"W 1310.23 feet to the point of beginning; thence N88°47'30"W 574.67 feet to an iron rod located near the shore of Spider Lake. Said line continues to the water's edge. Thence returning to the point of beginning and going S00°03'24"W 738.67 feet to an iron rod located near the shore of Spider Lake. Said line continues to the water's edge.

The above-described parcel contains 326,196 square feet, more or less, which is 7.49 acres, more or less, and includes all land between the meander line and the shore of Spider Lake.
