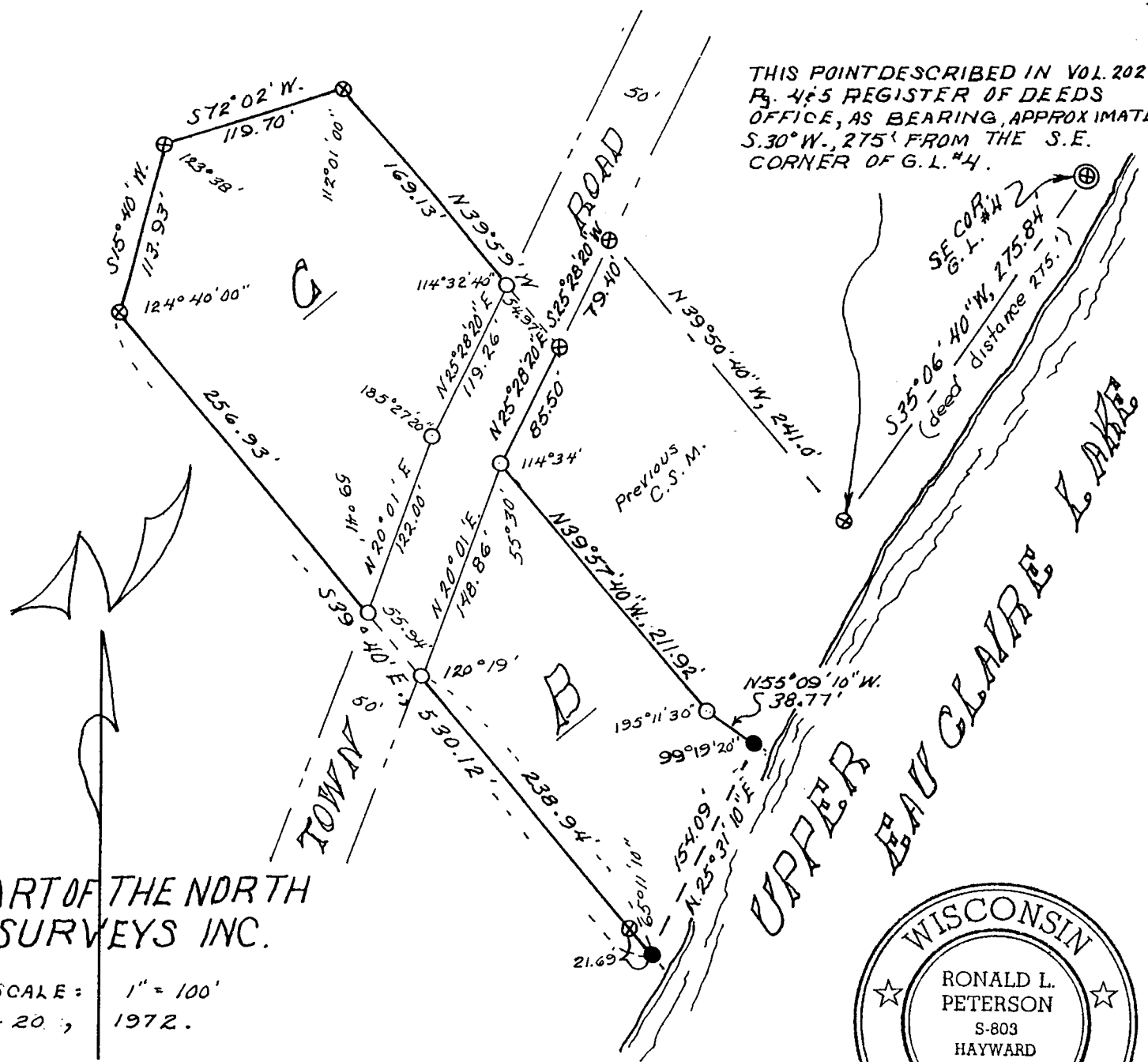

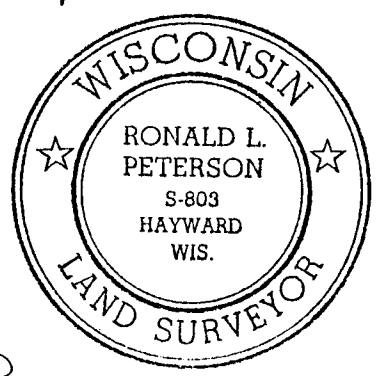
HEART OF THE NORTH SURVEYS INC.

to the actual point of beginning, Thence N. 39°59' W, 54.97 feet
to the northerly right-of-way line of said town road, Thence
continue N. 39°59' W, 169.13 feet, Thence S. 72°02' W. 119.70 feet,
Thence S. 15°40' W, 113.93 feet, Thence S. 39°40' E, 256.93 feet
