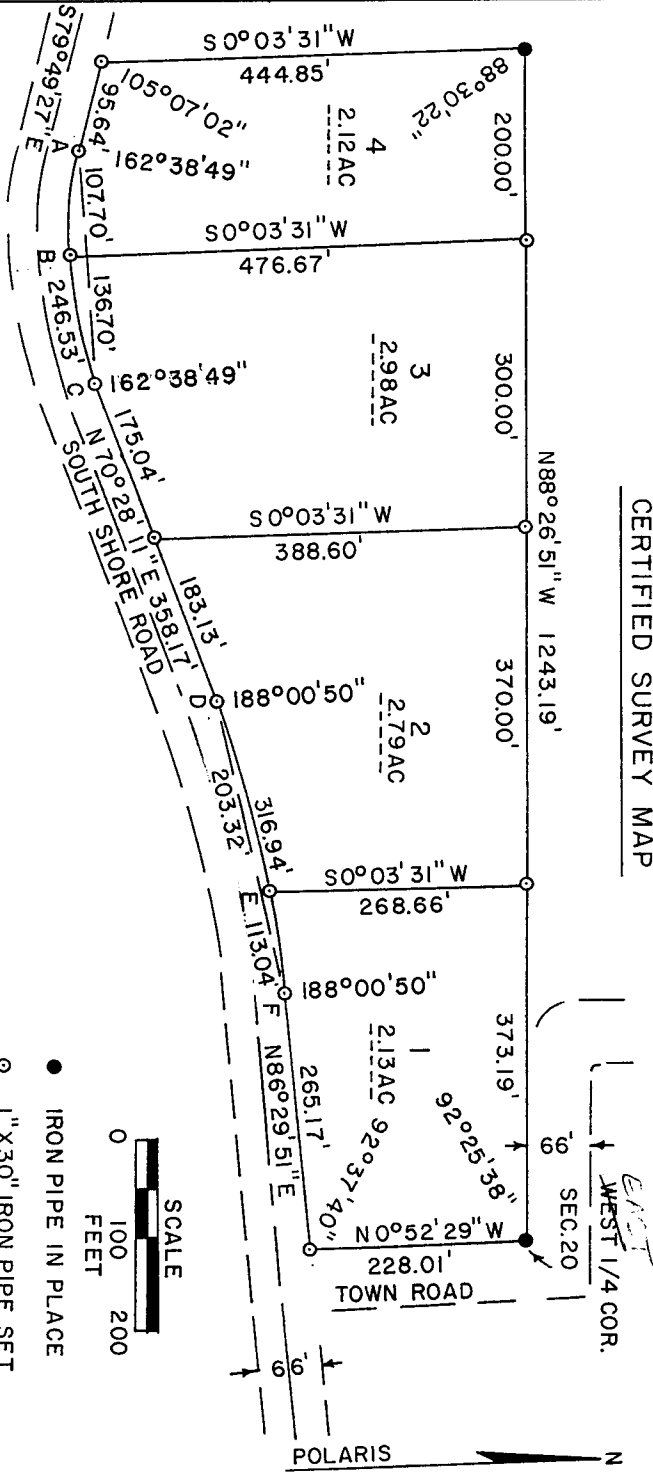

CERTIFIED SURVEY MAP

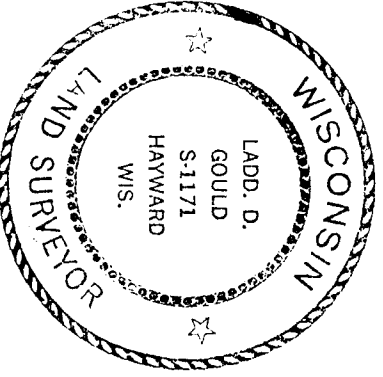

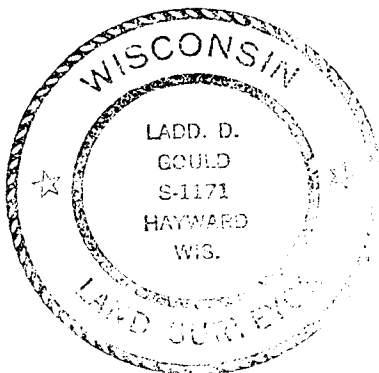
