The Bayfield County Planning and Zoning Committee of the County Board of Supervisors will hold a public hearing on Thursday, March 16, 2006 at 1:00 P.M. in the Board Room of the Bayfield County Courthouse in Washburn Wisconsin relative to the following:

**Paul Solberg and Jacqueline Thorn** are petitioning for a zoning district map amendment on their 13-acre parcel (ID #004-1102-05), located in the NW ¼ of the NW ¼, lying South and East of Pease Road in V. 914 Page 586, Section 12, Township 44 North, Range 9 West, Town of Barnes, Bayfield County, WI from Forestry-2 (F-2) to Residential-2 (R-2).
