Scott Bucher, owner and Todd Bucher, agent have petitioned for a zoning district map amendment for a 5.55-acre parcel located in the SE ¼ of the SW ¼ and the SW ¼ of the SE ¼, Section 8 and the NW ¼ of the NE ¼, Section 17, Township 46 North, Range 7 West, Town of Delta from Forestry-1 to Commercial.

Royden Bloom is requesting a conditional use permit to operate a blacksmith shop on his 4.14-acre parcel located in Lot 4 of CSM #973 V. 6 P. 230, in the SE ¼ of the SE ¼, Section 32, Township 45 North, Range 7 West, Town of Drummond.
