The Bayfield County Zoning Committee of the County Board of Supervisors will hold a public hearing on Tuesday, March 19, 2002 at 6:00 P.M. in the Board Room of the Bayfield County Courthouse in Washburn Wisconsin relative to the following:

Douglas & Joan Cybela are requesting a conditional use permit to exceed the 35' height restriction for their existing home located on their 1.34-acre parcel described as Gov't Lot 1, further described as Lot 8, Roy's Point Shores, Section 6, Township 50 North, Range 3 West, Town of Bayfield.

Jerry Johnson, owner, and Greg Carrier, Agent, are requesting a conditional use permit to exceed the 35' height restriction for their existing carriage house and unattached accessory structure located on a 3.29-acre parcel described as Lot 7 & 8 of Blue Wing Bay Subdivision, Section 23, Township 50 North, Range 4 West, Town of Bayfield.

Timothy Martens is petitioning for **a correction of his legal description** on his June 26, 2001 rezone for his 8-acre parcel described as that part of the SE ¼ of the SE 1/4, that lies South (S) of Long Lake Road, Section 34, Township 48, Range 8 West, Town of Tripp and North (N) of the section line of the NE ¼ of the NE ¼, Section 3, Township 47 North, Range 8 West, Town of Iron River, from Forestry-1 (F-1) to Residential-3 (R-3). **(Previous rezone stated all in Section 3)**

Ralph Frostman is requesting a conditional use permit for transfer of mineral rights to Mathey Construction Co. for a gravel pit on his 80-acre parcel described as the W ½ of the NW ¼, Section 26, Township 47, Range 8 West, Town of Iron River.

Glenn Berweger is requesting a conditional use permit for a gravel pit on his 30-acre parcel described as the SE ¼ of the NE ¼, Section 13, Township 45 North, Range 5 West, Town of Lincoln.

United States of America Dept. of Agriculture, has petitioned for a rezone on their 9.11-acre parcel described as Government Lots 6, 11 and 12, further described as Lots 1, and 3-12, Lake Owen-Lovers Bay Subdivision, Section 22, Township 44 North, Range 7 West, Town of Drummond from Forestry-2 (F-2) to Residential-1 (R-1).

described as the SW ¼ of the NE ¼, less a 5-acre parcel in the West ½ of the SE ¼, of the SW ¼ of the NE ¼, Section 23, Township 46, Range 6 West, Town of Mason.

Charles & Mary Buran have petitioned for a rezone of their 40-acre parcel described as the NE ¼ of the NE ¼, Section 8, Township 47 North, Range 9 West, Town of Hughes from Forestry-1 to Agriculture-1.
