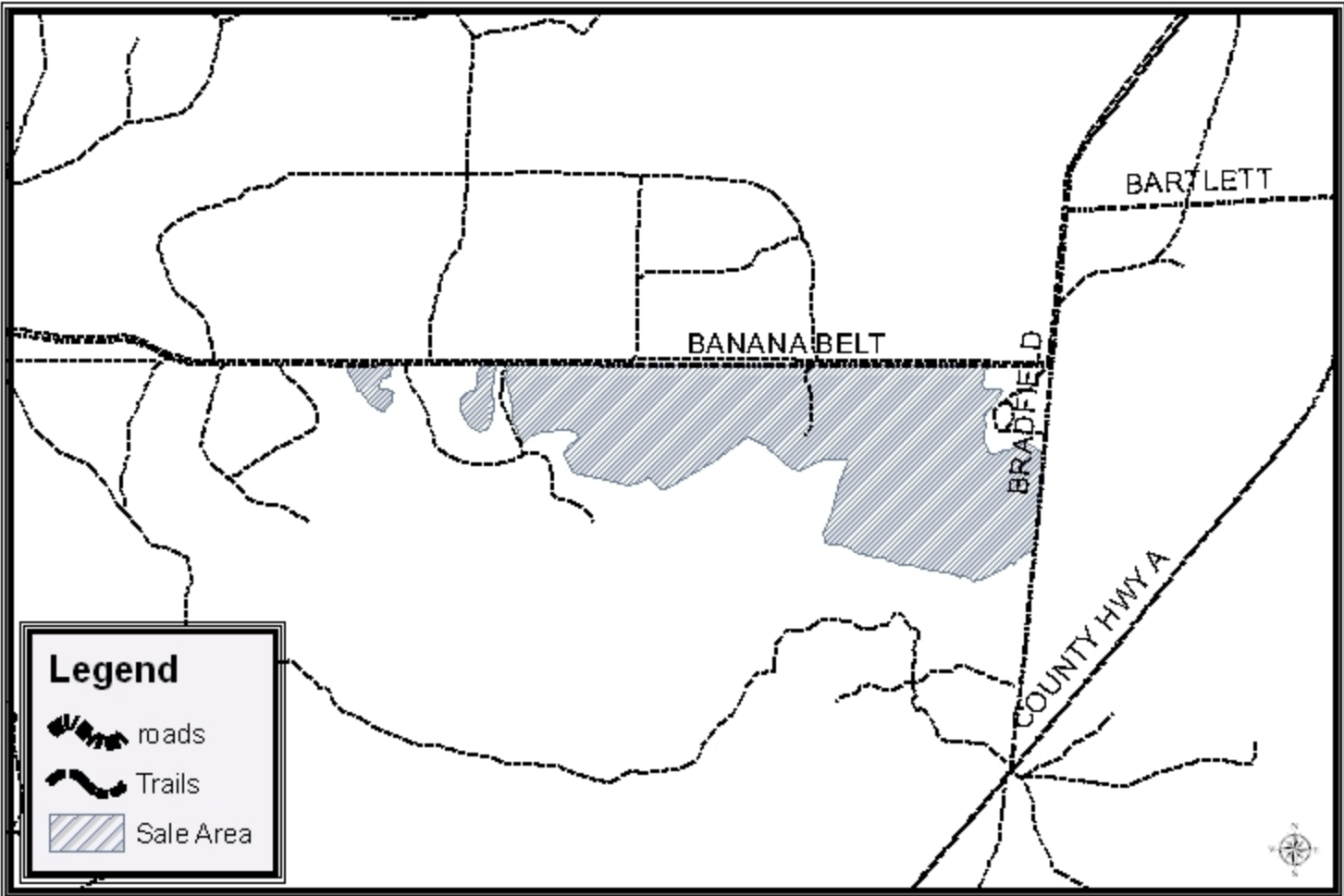

- Do not harvest or damage any Red and White Pine.
- Sever all non-merchantable stems of designated species to be cut 2" in diameter and greater
- Utilize all Hardwood to a 5' top and all softwood to a 4" top
- Decking of wood along town roads will not be allowed without proper permits and permission from the sale administrator.
- This contract requires County authorization for all road/landing construction and places a number of other requirements on road construction and closure (refer to section 17).
