1. The owner agrees to file a copy of this contract with **Bayfield County** as required in Title 15 of the Bayfield County Zoning Ordinance.
2. The owner agrees to have the Portable Restroom(s) serviced by the pumper and guarantees to permit the pumper to have access and to enter upon the property for the purpose of servicing the Portable Restroom(s). The owner agrees to maintain the access road or drive so that the pumper can service the Portable Restroom(s) with the pumping equipment. The owner further agrees to pay the pumper for all charges incurred in servicing the Portable Restroom(s) as mutually agreed upon by the owner and pumper.
3. The pumper agrees to submit to the local government unit which has signed the pumping agreement required by Title 15 of the Bayfield County Zoning Ordinance, a report for the servicing of the Portable Restroom(s) on a semiannual basis. The pumper further agrees to include the following in the semiannual report:
 - a. The name and address of the person responsible for servicing the Portable Restroom;
 - b. The name of the owner of the Portable Restroom;
 - c. The location of the property on which the Portable Restroom is installed;
 - d. The dates on which the Portable Restroom was serviced;
 - e. The volumes in gallons of the contents pumped from the Portable Restroom for each servicing;
 - f. The disposal sites to which the contents from the Portable Restroom were delivered.
4. This agreement will remain in effect until the owner or pumper terminates this contract. In the event of a change in this contract, the owner agrees to file a copy of any changes to this service contract and/or a copy of a new service contract with the local government unit (County) named above within (10) business days from the date of change to this service contract.
