The Bayfield County Planning and Zoning Committee of the County Board of Supervisors will hold a public hearing on Thursday, April 15, 2010 at **4:00 P.M.** in the Board Room of the Bayfield County Courthouse in Washburn Wisconsin relative to the following:

James Crandall, Clerk for the Town of Drummond, is petitioning for a text amendment change in the form of adding an overlay district **Section 13-1-66** specific to the Town of Drummond to allow for more restrictive standards and requirements than those currently utilized under the Bayfield County Zoning Ordinance; specifically 10-acre minimum parcels Ag-1 and F-1 zoning districts. (Draft language available in the Planning and Zoning Office).

Kenneth Abernathy, Jr. is petitioning for a zoning district map amendment in a shoreland-wetland zone. The property is a 20-acre parcel (ID #04-021-2-45-06-22-3-04-000-60000) (V. 1024 P. 209), located in S ½ of the SE ¼ of the SW ¼, Section 22, Township 45 North, Range 6 West, Town of Grand View, Bayfield County, WI from F-1, R-1, R-4 to all R-4.

Todd & Nina Bucher are petitioning for a zoning district map amendment in a shoreland-wetland zone. The property is an 8-acre parcel (ID #04-016-2-46-07-17-4-02-000-20000), located in part of the NW ¼ of the SE ¼, Section 17, Township 46 North, Range 7 West, lying North and West of the River in the Town of Delta, Bayfield County, WI from F-1 to all R-RB.

All interested parties are invited to attend said hearing to be heard.
