The Bayfield County Planning and Zoning Committee of the County Board of Supervisors will hold a public hearing on Thursday, January 20, 2010 at 1:00 P.M. in the Board Room of the Bayfield County Courthouse in Washburn Wisconsin relative to the following:

**A petition by Karl Kastrosky, Director of Planning and Zoning, on behalf of the Bayfield County Planning and Zoning Committee, requesting amendments to the Bayfield County Zoning and Subdivision Control Ordinances, including the following:**

1. Amendment removing the requirement that a Conservation Subdivision in an A-1 or F-1 zoning district have no more than three units.
2. Amendment removing reference to the requirement that a Conservation Subdivision in an A-1 or F-1 zoning district have no more than three units.
