The Bayfield County Planning and Zoning Committee of the County Board of Supervisors will hold a public hearing on Thursday, September 15, 2005 at 1:00 P.M. in the Board Room of the Bayfield County Courthouse in Washburn Wisconsin relative to the following:

**Bayfield County, owner and Wanda Hyde, agent** are requesting a conditional use permit on a parcel of land leased to the Dept. of Natural Resources and sub-leased to the Ashland Bayfield County Sportsmen's Club to construct and operate a rifle range on a 20-acre parcel (ID# 010-1047-07-000), located in the W ½ of the SW ¼ of the SE ¼, Section 36, Township 50 N, Range 6 West, Town of Bell, Bayfield County, WI.

**James M. Bigott** is requesting an expansion of an existing non-conforming (grandfathered) resort consisting of 2 rental cabins and a residence with a conversion of a non-conforming accessory building to a bar/bait shop. The property is a .80-acre parcel (ID#034-1123-01, described as Lots 7-9, Block 5, Plat of Namakagon Village, Town of Namakagon, Bayfield County, WI.

**Todd Lechner** is petitioning for a zoning district map amendment on his 120-acre parcel(s) (ID #'s 004-1221-03, 004-1221-04 and 004-1219-04), described as the NE ¼ of the SW ¼, the NW ¼ of the SW ¼, of Section 35 and the NE ¼ of the SE ¼, Section 34, all in Township 45 North, Range 9 West, Town of Barnes, Bayfield County, WI from Forestry-2 (F-2) to Forestry-1 (F-1).

**Ugo & Marcia Racheli** are requesting a conditional use to operate a café/restaurant and bar/tavern on their 5.1-acre parcel (ID# 008-1032-04-990), located in part of the W ½ of the SW ¼ of the SE ¼, Section 28, Township 49 North, Range 4 West, Town of Bayview, Bayfield County, WI.

All interested parties are invited to attend said hearing to be heard. Immediately after the public hearing, the Planning and Zoning Committee will hold its regular monthly meeting.
