Notice is hereby given that a public hearing will be held on **Thursday, September 22, 2005** at 9:00 a.m. in the County Board Room of the Bayfield County Courthouse, Washburn Wisconsin relative to the following item(s):

Clyde L. Sukanen, Clyde James Sukanen, and Carl G. Sukanen are seeking a variance based upon the denial of the Zoning Department. The variance being sought is from the terms of Section 13-1-22(b) of the Bayfield County Zoning Ordinance. This section requires buildings be setback 110' from the centerline of a State Highway or 50' from the right-of-way whichever is greater. Applicants seek to construct a 918 sq. ft home 10' from the right-of-way of State Hwy 13. The parcel is described as a 1.4-acre parcel (ID#002-1005-06-990), located in Gov't Lot 1, Section 18, Township 48 North, Range 4 West, Town of Barksdale.
