# PUBLIC HEARING

Please be advised that the Bayfield County Land Conservation Committee and the Bayfield County Board of Supervisors will hold a public hearing on **November 8<sup>th</sup>, 2019 at 9:00 A.M.** in the EOC of the Bayfield County Annex Building in Washburn, Wisconsin to the following:

Wisconsin law requires each county to have a Land and Water Resource Management Plan that has been approved by the Wisconsin Department of Agriculture, Trade and Consumer Protection (DATCP). The Land and Water Conservation Board reviews the completed plans and recommends action to DATCP. Plans are approved for a 10-year period, with a review by the Land and Water Conservation Board in year 5.

The Bayfield County Land and Water Conservation Department has started the revision of our 10 year plan (2020-2030) and is seeking input from the general public for ideas or directions on where they want to see the department heading over the next decade and to submit public comment in person and/or in writing.
